

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Any US Citizen

MAJOR DUTIES:

The incumbent is responsible for functions to include: assisting in the development of policies, procedures and criteria for administration of organization's health science research program. The incumbent will also perform a variety of administrative duties to maintain specialized data and assist in the implementation of Study designs. Maintains records, prepare project administrative and statistical reports for review process. The incumbent has the ability to retrieve laboratory reports, and other relevant patient data. The incumbent is responsible for functions to include: Performing a variety of administrative tasks associated with maintaining and supporting the work performed within an organization. The incumbent will also perform a variety of administrative duties to maintain specialized research data. Monitors and controls business papers, correspondence, and records, including the coordination of action papers with office and agency staff. Receives, assigns, and monitors externally and internally generated correspondence and inquires.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: U.S. Office of Personnel Management Qualification Standards Handbook for GS-0640, Health Technician series applies and may be reviewed in the Human Resources Management Service office. Applicants must meet basic requirements as well as specialized experience and/or education requirements to qualify.

Specialized Experience: At least one year of specialized experience that equipped the applicant with the particular knowledge, skills and abilities necessary to successfully perform the duties of this position. This one-year of specialized experience must have been comparable to the next lower level in the Federal Service. Experience must have been related to the work of the position for which application is made. Example of qualifying specialized experience include: work as a Health Science Specialist, Health Technician, Health Aid or similar position for a large Medical or Research facility.

Substitution of Education for Experience: If using education as a substitute for experience, please submit a copy of your college transcripts or school record of credit hours with application packet. Successful completion of a four year course of study above the high school level leading to a bachelor's degree is qualifying. This education must have been obtained in an accredited business, secretarial or technical school, junior college, college or university.

BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to rating factors may result in your application receiving a less than desirable rating:

1. Ability to create and edit scientific documents.
2. Ability to review complex scientific documents and summarize the findings.
3. Ability to conduct open and closed ended interviews and record valid responses from participants in research projects.
4. Ability to organize complicated information and keep accessible files.
5. Ability to communicate complex study procedures to research participants.

CONDITIONS OF EMPLOYMENT:

- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire non citizens only in very limited circumstances where there are no qualified citizens available for the position.
- A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled

substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

- If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.
- Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.
- A pre-employment physical examination will be required for an applicant who is tentatively selected.
- A drug test may be required for an applicant who is tentatively selected.
- This agency provides reasonable accommodations to applicants with disabilities. If you need a reasonable accommodation for any part of the application and hiring process, please notify the agency. The decision on granting reasonable accommodation will be on a case-by-case basis
- All qualified applicants will receive equal consideration without regard to race, religion, color, national origin, sex, politics, marital status, non-disqualifying physical or mental handicap, age or membership or non-membership in a labor organization.

1. [OF 612, Optional Application for Federal Employment](#), or Resume. (Please refer to [OF-510, Applying for a Federal Job](#) on the USA jobs website (<http://www.usajobs.opm.gov/>) for information on how to apply with a resume instead of OF-612
2. [OF-306, Declaration for Federal Employment](#) (January 2001 version or later). (REQUIRED).
3. Veterans Preference:
 - a. DD-214, Military Discharge Paper (member copy #4 for July 1979 or later editions) (For 5 Point Veteran's Preference).
 - b. [SF-15, Application for 10-point Veteran Preference](#) (December 2004 version or later)
 - c. VA letter of service-connected disability rating dated 1991 or later.
4. SF-50, Notification of Personnel Action (if applying as a current or former federal employee).
5. Narrative statement relating to all of the KSAs. Candidates must submit a narrative statement on a separate page(s) with specific responses to all of the knowledge, skills, and abilities (KSAs) in this announcement. Failure to submit your narrative response to all of the KSAs will result in the applicant not being referred for the position.
6. A copy of your college transcripts (Optional unless education is required).

APPLICANT'S PLEASE NOTE:

- Education must be accredited by an accrediting institution recognized by the U.S. Department of Education in order for it to be credited towards qualifications (particularly positions with a positive education requirement.). Therefore, applicants must report only attendance and/or degrees from schools accredited by accrediting institutions recognized by the U.S. Department of Education.
