

### WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Any US Citizen

### MAJOR DUTIES:

The Health Promotion and Disease Prevention Manager advises facility and primary care leadership on clinical and administrative issues related to health promotion and disease prevention, including clinical preventive services. The RN advocates for policy and program development and resource allocation to support health promotion and disease prevention programs and services for Veterans. He/she leads the effort to identify health promotion/disease prevention challenges, priorities for improvement, and opportunities for disseminating and sustaining best practices. The RN is Primary facility point of contact for national health promotion campaigns and events, ensuring local implementation and participation (includes HealthierUS Veterans). Is the primary facility point of contact for planned national Health Risk Assessment for Veterans. This includes: a) responsibility for engaging all relevant VHA stakeholders within the facility including but not limited to Chief of Staff (COS), Nurse Executive, Associate Chief of Staff (ACOS) for Ambulatory Care, My HealthVet point of contact, HPDP Committee, providers and clinicians to implement HRA, and; b) assisting in the development and completion of monitoring reports related to facility uptake of the HRA when available. The incumbent develops or coordinates the development of user-friendly tools to assist in successful implementation of health promotion and disease prevention programs and services. Additionally the incumbent provides leadership in the development or modification of service delivery processes to support the successful implementation of health promotion and disease prevention programs and services.

### QUALIFICATION REQUIREMENTS:

**Experience:** 3-5 years experience in health promotion and/or public health required, preferred 1-3 years management experience in public health

**Eligibility:** Department of Veterans Affairs Qualifications Standards (VA Handbook 5005, Part II, Appendix G6) for AD/VN-610 series applies and may be reviewed in the Human Resources Management Service Office.

- Citizen of United States
- Graduate of a school of professional nursing approved by the appropriate State agency and accredited by one of the following accrediting bodies at the time the program was completed by the applicant: The National League for Nursing Accrediting Commission (NLNAC) or The Commission on Collegiate Nursing Education (CCNE).
- In cases of graduates of foreign schools of professional nursing, possession of current, full, active, and unrestricted registration and the possession of a Certificate from the Commission on Graduates of Foreign Nursing Schools (CGFNS) will meet the requirement of graduation from an approved school of professional nursing.
- Current, full, active and unrestricted registration as a graduate professional nurse in a State, Territory, or Commonwealth (i.e., Puerto Rico) of the U.S. or in the District of Columbia. The RN must maintain a current, full active and unrestricted registration to continue employment with the VA.
- For Nurse II, the applicant will have a BSN with 2-3 years of nursing experience **OR** an Associate degree or diploma in nursing and a bachelors degree in a related field and 2-3 years nursing experience **OR** a Master's degree in

nursing or a related field with a BSN with 1-2 years of experience.

- For Nurse III, the applicant will have a Master's degree in nursing or related field with a BSN and 2-3 years of nursing experience OR a Doctoral degree in nursing or related field and 2-3 years of nursing experience.
- For Nurse IV, the applicant will have a Master's degree in nursing or related field with a BSN and 4-5 years of nursing experience OR a Doctoral degree in nursing or related field and 3-4 years of nursing experience.

### **CONDITIONS OF EMPLOYMENT:**

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

All information submitted to this VA Medical Center is subject to verification by VetPro.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.

Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

Applicants selected for this position may be appointed to a temporary appointment, NTE 13 months, pending completion of boarding process.

A drug test may be required for an applicant who is tentatively selected.

A pre-employment physical examination will be required for an applicant who is tentatively selected.

Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).
