

### WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Any US Citizen

**Applicants who applied under announcement T38-07-534-LS need not reapply as they will be considered under this announcement.**

### MAJOR DUTIES:

The incumbent is assigned as a clinician-educator or clinician-researcher of the Section of Pulmonary and Critical Care Medicine and will serve as the Section Chief. The position includes a major role as the director of an inpatient Intensive Care Unit Medicine Team (inpatient attending) and will also lead a Pulmonary Consultation Team. The incumbent will also see patients for, at least, one four-hour clinic each week, with an additional 25% of time for indirect activities of patient care such as dictation, returning telephone calls, reviewing and signing dictated notes, reviewing and renewing prescriptions, and reviewing laboratory and imaging data. The amount of time spent in clinical duties will be based on whether the incumbent is a clinician-researcher or clinician-educator, using the DHSM time allocation model. The incumbent will be assigned administrative or managerial responsibilities through participation in clinical and educational administrative committees, chairing committees, task groups or special projects and quality management/quality of care responsibilities. Manages educational programs at PVAMC and participates in teaching activities of the OHSU Division of Pulmonary and Critical Care Medicine. As the Section Chief, the incumbent will be responsible for directing and supervising the physicians assigned to the Section. The incumbent is responsible for the overall management and direction of the Section and its resources.

### QUALIFICATION REQUIREMENTS:

**Eligibility:** Department of Veterans Affairs Qualifications Standards (VA Handbook 5005, Part II, Appendix G2) applies and may be reviewed in the Human Resources Management Service Office.

- Must be a citizen of the United States.
- Must have a Degree of doctor of medicine or an equivalent degree resulting from a course of education in medicine or osteopathic medicine.
- Must provide evidence of an active, current, full and unrestricted license to practice Medicine or Surgery in a State, Territory or Commonwealth of the U.S. or the District of Columbia.
- Must be board-certified or board eligible in Pulmonary. Board-eligible candidates will be appointed to temporary appointments and may be converted on passing their boards.

### CONDITIONS OF EMPLOYMENT:

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

All information submitted to this VA Medical Center is subject to verification by VetPro.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or

disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

The applicant selected for this position will be eligible to apply for an education loan reimbursement award under the provisions of the Education Debt Reduction Program (EDRP).
