

**WHO MAY APPLY TO THIS ANNOUNCEMENT:**

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Any US Citizen
- **First consideration date 02/06/09.** After the first consideration date, applicants will then be referred in intervals. If the position is filled before the closing date the vacancy will be closed.

**MAJOR DUTIES:**

A General Surgery Physician is responsible for participating in and/or managing all aspects of a general surgery program, to include clinical, administrative, academic and research components. He/She is accountable to the General Surgery Section Chief, Chief, Surgical Service, and Operative Care Division Director for assuring the most effective delivery of care in general surgery while meeting and exceeding compliance standards. He/She will have responsibility and decision-making ability for general surgery patient-care issues. Duties include, but are not limited to; delivering care to the veteran requiring surgery or have surgery-related illnesses. Work with multiple Division/Services throughout the facility to improve outcomes and efficiencies. Collaborates on a frequent basis with nursing and others to facilitate the operations of the ICU's/wards/ECU, etc. to meet common goals. Provides Clinical coverage as needed by the general surgery team. Establishes and promotes an atmosphere of unity through collaborative practice and effective communication between all staff disciplines. Fosters high level of patient and staff satisfaction.

**QUALIFICATION REQUIREMENTS:**

**Eligibility:** Department of Veterans Affairs Qualifications Standards (VA Handbook 5005, Part II, Appendix G2) for AD/VM-602 series applies and may be reviewed in the Human Resources Management Service Office.

- Must be a citizen of the United States.
- Must have a Degree of doctor of medicine or an equivalent degree resulting from a course of education in medicine or osteopathic medicine.
- Must provide evidence of an active, current, full and unrestricted license to practice Medicine or Surgery in a State, Territory or Commonwealth of the U.S. or the District of Columbia.
- Must be board-certified or board eligible in General Surgery through the American Board of Surgery.
- Must demonstrate expertise in the academic missions of education and research.
- Previous experience with complex surgical patient care, surgical research, and demonstrated supervisory skills are highly desirable but not requisite.

**CONDITIONS OF EMPLOYMENT:**

- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.
- All information submitted to this VA Medical Center is subject to verification by VetPro.
- If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.
- A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or

- reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.
- Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.
  - Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
  - The applicant selected for this position will be eligible to apply for an education loan reimbursement award under the provisions of the Education Debt Reduction Program (EDRP).
  - Relocation incentive may be authorized.
  - Recruitment incentive may be authorized.
  - A drug test may be required for an applicant who is tentatively selected.
  - A pre-employment physical examination will be required for an applicant who is tentatively selected.
  - Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).
