

**WHO MAY APPLY TO THIS ANNOUNCEMENT:**

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Any US Citizen
- **First consideration date 03/30/09.** After the first consideration date, applicant will then be referred in intervals. If the position is filled before the closing date the vacancy will be closed.

**MAJOR DUTIES:**

The Sterile Processing Center (SPC) Manager provides leadership and management within Acquisition & Materials Management. The SPC Manager identifies and maintains SPC standards of care in all services provided. The incumbent demonstrates expertise and comprehensive understanding of patient care practices, asepsis and disinfection/sterilization. This role involves clinical, administrative, research and educational components which impact patients and healthcare personnel throughout the health care system. The incumbent participates in assessing the decontamination, high level disinfection/sterilization process inside and outside of SPC. The incumbent ensures the practice of SPC is consistent with the VA Standards (i.e. VA Handbook 7176), VISN 20 policies/procedures and external regulatory standards, such as Joint Commission, AORN, OSHA, FDA and AAMI. The SPC Manager plays a leadership role in assuring ongoing systematic evaluation, improvement of quality and effectiveness of SPC processes and practices. The incumbent assesses educational needs of the SPC staff and develops and implements appropriate educational plan to meet core and specialty competencies. The SPC Manager collaborates with all service lines within PVAMC, particularly Operative Care Division and Infection Control. She/he will be responsible for meeting all performance goals including: quality of care standards, productivity targets, efficiency and process improvement measures, patient/customer satisfaction, accessibility to care, and budgetary targets.

**QUALIFICATION REQUIREMENTS:**

**Eligibility:** Department of Veterans Affairs Qualifications Standards (VA Handbook 5005, Part II, Appendix G6) for AD/VN-610 series applies and may be reviewed in the Human Resources Management Service Office.

- Citizen of United States
- Graduate of a school of professional nursing approved by the appropriate State agency and accredited by one of the following accrediting bodies at the time the program was completed by the applicant: The National League for Nursing Accrediting Commission (NLNAC) or The Commission on Collegiate Nursing Education (CCNE).
- In cases of graduates of foreign schools of professional nursing, possession of current, full, active, and unrestricted registration and the possession of a Certificate from the Commission on Graduates of Foreign Nursing Schools (CGFNS) will meet the requirement of graduation from an approved school of professional nursing.
- Current, full, active and unrestricted registration as a graduate professional nurse in a State, Territory, or Commonwealth (i.e., Puerto Rico) of the U.S. or in the District of Columbia. The RN must maintain a current, full active and unrestricted registration to continue employment with the VA.
- For Nurse II, the applicant will have a BSN with 2-3 years of nursing experience **OR** an Associate degree or diploma in nursing and a bachelors degree in a related field and 2-3 years nursing experience **OR** a Master's degree in nursing or a related field with a BSN with 1-2 years of experience.
- For Nurse III, the applicant will have a Master's degree in nursing or related field with a BSN and 2-3 years of nursing

- experience OR a Doctoral degree in nursing or related field and 2-3 years of nursing experience.
- For Nurse IV, the applicant will have a Master's degree in nursing or related field with a BSN and 4-5 years of nursing experience OR a Doctoral degree in nursing or related field and 3-4 years of nursing experience.
- **The preferred candidate should have three (3) or more years of experience with surgical instrumentation.**

#### **CONDITIONS OF EMPLOYMENT:**

- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.
- All information submitted to this VA Medical Center is subject to verification by VetPro.
- If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.
- A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.
- Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.
- Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
- Applicants selected for this position may be appointed to a temporary appointment, NTE 13 months, pending completion of boarding process.
- The applicant selected for this position will be eligible to apply for an education loan reimbursement award under the provisions of the Education Debt Reduction Program (EDRP).
- Relocation incentive may be authorized.
- Recruitment incentive may be authorized.
- A drug test may be required for an applicant who is tentatively selected.
- A pre-employment physical examination will be required for an applicant who is tentatively selected.
- Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).
