

### WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Any US Citizen
- **First consideration date 03/27/09.** After the first consideration date, applicant will then be referred in intervals. If the position is filled before the closing date the vacancy will be closed.
- **NOTE: Applicants who previously applied to T38-09-561-SJ will be considered under this announcement and need not re-apply.**

### MAJOR DUTIES:

The Clinical Director, Primary Care division has co-responsibility for the operations of the medical center's Primary Care Division at all sites of care, Occupational health, Anticoagulation and Compensation and Pension programs. In addition, the Clinical Director, in collaboration with the Administrative Director, will support the Medical Service House staff Education Program relative to continuity practices of house staff in the Primary Care environment. There will be joint accountability with the Administrative Director, Primary Care Division providing oversight and guidance to Division staff and patient care lines. The Clinical Director will help assure that Division activities meet national Joint Commission accreditation standards. Accountable to the Chief of Staff for assuring high quality, accessible and cost effective primary care throughout the program while meeting or exceeding performance standards. The Clinical Director must be comfortable with a matrix organization.

### **THIS POSITION IS EXCLUDED FROM THE BARGAINING UNIT**

### QUALIFICATION REQUIREMENTS:

**Eligibility:** Department of Veterans Affairs Qualifications Standards (VA Handbook 5005, Part II, Appendix G2) for AD/VM-602 series applies and may be reviewed in the Human Resources Management Service Office.

- Must be a citizen of the United States.
- Must have a Degree of doctor of medicine or an equivalent degree resulting from a course of education in medicine or osteopathic medicine.
- Must provide evidence of an active, current, full and unrestricted license to practice Medicine or Surgery in a State, Territory or Commonwealth of the U.S. or the District of Columbia.
- Must be board-certified or board eligible in Internal Medicine and/or Family Practice with demonstrated clinical excellence in patient care.
- **Preferred candidates will have significant leadership experience in operations, planning, and supervising primary care program(s) in a tertiary care environment.**
- **Preferred candidates will have expertise in the academic missions of education and research, and credentials warranting academic appointment as an Associate/Full Professor of Medicine.**

### CONDITIONS OF EMPLOYMENT:

- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and

Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

- All information submitted to this VA Medical Center is subject to verification by VetPro.
- If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.
- A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.
- Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.
- Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
- The applicant selected for this position will be eligible to apply for an education loan reimbursement award under the provisions of the Education Debt Reduction Program (EDRP).
- Relocation incentive may be authorized.
- Recruitment incentive may be authorized.
- A drug test may be required for an applicant who is tentatively selected.
- A pre-employment physical examination will be required for an applicant who is tentatively selected.
- Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).

**APPLICANT'S PLEASE NOTE:**

- Education must be accredited by an accrediting institution recognized by the U.S. Department of Education in order for it to be credited towards qualifications (particularly positions with a positive education requirement.).
