

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Any US Citizen

MAJOR DUTIES:

Staff general dentist has responsibility for providing the complete range of dental care to patients including removable and fixed prosthodontics, periodontics, oral surgery, restorative dentistry, endodontics and restoration of implants. Patient population includes medically compromised, outpatients, inpatients and nursing home patients.

Services Provided to include: General Dentistry, Oral Surgery, Periodontics, and Prosthodontics. Incumbent to provide direct patient care in a hospital dental clinic. Provides training to general practice and prosthodontic residents in accordance with supervision policies and procedures. Participates in administrative, policy and quality management activities essential to delivery of quality dental care. Meets clinical requirements for patient care and meets continuing education requirements. Fosters a high level of patient and staff satisfaction.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: Department of Veterans Affairs Qualifications Standards (VA Handbook 5005, Part II, Appendix G2) for AD/VM-602 series applies and may be reviewed in the Human Resources Management Service Office.

- Must be a citizen of the United States.
- Degree of doctor of dental surgery or dental medicine resulting from a course of education in dentistry. The degree must have been obtained from one of the schools approved by the Secretary of Veterans Affairs for the year in which the course of study was completed.
- Must provide evidence of an active, current, full and unrestricted license to practice Medicine or Surgery in a State, Territory or Commonwealth of the U.S. or the District of Columbia.
- Must be board-certified or board eligible in dental surgery or dental medicine.

CONDITIONS OF EMPLOYMENT:

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

All information submitted to this VA Medical Center is subject to verification by VetPro.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

APPLICANT'S PLEASE NOTE:
