

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Any US Citizen
- **First consideration date 07/06/09.** After the first consideration date, applicants will then be referred in intervals. If the position is filled before the closing date the vacancy will be closed.

MAJOR DUTIES:

The Nurse Practitioner (NP) practices in the Neurology and Seizure Clinics within Epilepsy Center of Excellence (ECoE) and Neurology Services, Mental Health and Neuroscience Division of the Portland VA Medical Center. The NP functions with delineated clinical privileges granted by the Executive Committee of the Medical Staff. The Epilepsy Nurse Practitioner provides primary care to adults with Epilepsy and/or related disorders in an outpatient setting. Primary care includes assessment, diagnosis and treatment of health care problems. This includes the following: initiating and adjusting therapeutic regimens, performing histories and physicals, ordering diagnostic and therapeutic tests/studies, initiating consults and referrals and prescribing medications/supplies in accordance with VA policy, VA formulary and State regulations. In addition, the NP serves as a consultant to nursing, as well as medical staff for patients with complex treatment of care needs. The NP works collaboratively with other interdisciplinary team members in providing quality care, and patient education to patients, participating in research activities, and additionally, assisting patients in acute and chronic rehabilitation techniques. The NP provides nursing education on the epilepsy inpatient unit, and helps to develop expanded patient care programs in the outpatient setting. The NP serves on Medical Center committees/task groups, and assists in the development, evaluation, and communication of policies and standards of nursing practice for neuroscience nursing. The NP may supervise nursing graduate interns.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: Department of Veterans Affairs Qualifications Standards (VA Handbook 5005, Part II, Appendix G6) for AD/VN-610 series applies and may be reviewed in the Human Resources Management Service Office.

- Citizen of United States
- Graduate of a school of professional nursing approved by the appropriate State agency and accredited by one of the following accrediting bodies at the time the program was completed by the applicant: The National League for Nursing Accrediting Commission (NLNAC) or The Commission on Collegiate Nursing Education (CCNE).
- In cases of graduates of foreign schools of professional nursing, possession of current, full, active, and unrestricted registration and the possession of a Certificate from the Commission on Graduates of Foreign Nursing Schools (CGFNS) will meet the requirement of graduation from an approved school of professional nursing.
- Current, full, active and unrestricted registration as a graduate professional nurse in a State, Territory, or Commonwealth (i.e., Puerto Rico) of the U.S. or in the District of Columbia. The RN must maintain a current, full active and unrestricted registration to continue employment with the VA.
- A nurse practitioner must possess a master's degree from a program accredited by the NLNAC or CCNE.
- A nurse practitioner must be licensed or otherwise recognized as a nurse practitioner in a State, and maintain full

and current certification as a nurse practitioner from the American Nurses Association or another nationally recognized certifying body. Nurse Practitioners must be licensed with prescriptive privileges by the Oregon State Board of Nursing.

CONDITIONS OF EMPLOYMENT:

- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position
- All information submitted to this VA Medical Center is subject to verification by VetPro.
- Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
- Applicants selected for this position may be appointed to a temporary appointment, NTE 13 months, pending completion of boarding process.
- If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.
- A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.
- Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.
- A drug test may be required for an applicant who is tentatively selected.
- A pre-employment physical examination will be required for an applicant who is tentatively selected.
- Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).

APPLICANT'S PLEASE NOTE:
