

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- U.S. Citizens who are enrolled or eligible to be enrolled into an approved online, distance-learning Clinical Laboratory Science training program

MAJOR DUTIES:

The incumbent is a Student Trainee Medical Laboratory Technician. Duties are primarily in the Hematology/Coagulation, Microbiology, Chemistry/Urinalysis, and Immunohematology/Immunology areas where the incumbent serves as one of the personnel normally assigned to that area. The employee is required to rotate through all areas of the laboratory as scheduled. The employee is required to meet all requirements of the learning objectives and to remain in good standing with the participating university or college Clinical Laboratory Science program.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: U.S. Office of Personnel Management Qualification Standards Handbook for GS-645, Medical Technician series and Technical and Medical Support Positions apply and may be reviewed in the Human Resources Management Service office.

Education: Successful completion of four years of study leading to a bachelor's degree with 24 hours of science courses in chemistry, biology or medical laboratory technology in any combination.

CONDITIONS OF EMPLOYMENT:

This is an Excepted Appointment. Excepted service positions have been excepted from the requirements of the competitive service by law, Executive Order, or by OPM regulation (5 USC 2103 and 5 CFR part 213).

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

All information submitted to this VA Medical Center is subject to verification by VetPro.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.

A drug test may be required for an applicant who is tentatively selected.

A pre-employment physical examination will be required for an applicant who is tentatively selected.

Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).

 - c. VA letter of service-connected disability rating dated 1991 or later.
4. SF-50, Notification of Personnel Action (if applying as a current or former federal employee).
5. Copies of all current licenses, registrations, or certifications (applicable to job).
6. A copy of your college transcripts (Optional unless education is required).

APPLICANT'S PLEASE NOTE:
