

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Any US Citizen
- **Those that applied under announcement T38-10-0062-SJ do not need to reapply as they will be considered under this announcement also.**

MAJOR DUTIES:

The Diabetes/Hypertension Nurse Practitioner (NP) is an independent member of the Medical Staff, with delineated clinical privileges. The NP is a member of an interdisciplinary team educating and managing patients with complex diabetes and/or hypertension. The NP also follows a selected panel of primary care patients with diabetes and or hypertension. This includes performing histories and physicals, ordering and interpreting diagnostic and therapeutic tests/studies, initiating consults and referrals, prescribing medications and supplies in accordance with VA policy, VA formulary and State regulations and formulating, initiating and evaluating health care teaching for patients and their families. The NP is a consultant to medical and nursing staff and VISN 20 clinical leadership on the care of complicated diabetic and hypertensive patients throughout the medical center. The Diabetes NP designs, implements and evaluates individual and group diabetic education programs. The NP is a member of the interdisciplinary teaching team with responsibility for providing continuing education for a variety of health care professionals at VA and in the community and for precepting a variety of health care trainees including NP and RN students and Internal Medicine Residents.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: Department of Veterans Affairs Qualifications Standards (VA Handbook 5005, Part II, Appendix G6) applies and may be reviewed in the Human Resources Management Service Office.

- Citizen of United States
- Graduate of a school of professional nursing approved by the appropriate State agency and accredited by one of the following accrediting bodies at the time the program was completed by the applicant: The National League for Nursing Accrediting Commission (NLNAC) or The Commission on Collegiate Nursing Education (CCNE).
- In cases of graduates of foreign schools of professional nursing, possession of current, full, active, and unrestricted registration and the possession of a Certificate from the Commission on Graduates of Foreign Nursing Schools (CGFNS) will meet the requirement of graduation from an approved school of professional nursing.
- Current, full, active and unrestricted registration as a graduate professional nurse in a State, Territory, or Commonwealth (i.e., Puerto Rico) of the U.S. or in the District of Columbia. The RN must maintain a current, full active and unrestricted registration to continue employment with the VA.
- A nurse practitioner must be licensed or otherwise recognized as a nurse practitioner in a State, and maintain full and current certification as a nurse practitioner from the American Nurses Association or another nationally recognized certifying body. Nurse Practitioners must be licensed with prescriptive privileges by the Oregon State

Board of Nursing.

- Additional qualifications for a Nurse Practitioner in Diabetes include certification as Diabetes Educator (CDE).

CONDITIONS OF EMPLOYMENT:

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future. Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.

All information submitted to this VA Medical Center is subject to verification by VetPro.

Applicants selected for this position may be appointed to a temporary appointment, NTE 13 months, pending completion of boarding process.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

A drug test may be required for an applicant who is tentatively selected.

A pre-employment physical examination will be required for an applicant who is tentatively selected.

Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38USC 7402(d) and 7407(d).

APPLICANT'S PLEASE NOTE:
