

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees, Veteran's Canteen Service and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement.
- Any US Citizen
- **First consideration date 06/08/10.** After the first consideration date, applicant will then be referred in intervals. If the position is filled before the closing date the vacancy will be closed.

MAJOR DUTIES:

The specialist in geriatric medicine provides direct comprehensive patient care in an outpatient and/or hospital setting to older adults with acute and chronic medical conditions and serves as a consultant to other physicians. The geriatrician is expert in history taking, physical examination, test interpretation, patient counseling and differential diagnosis and medical therapeutics. The geriatrician evaluates and manages adults who have single or multiple disorders in all of the subspecialties in the broad field of internal medicine and specifically geriatric medicine. Geriatricians provide care to patients in primary, secondary and tertiary care settings. The practice of geriatric medicine is not delimited by the location in which a patient is seen, but may occur in a wide variety of settings including homes, nursing homes, clinics, emergency rooms, urgent care clinics and inpatient wards including intensive care units. The specialist in Geriatric Medicine has passed the Certification Exam in Geriatric Medicine and received a Certificate of Added Qualification (CAQ). A "full-time clinician with teaching and/or research responsibilities" will divide his/her time between research, direct patient care, supervision of trainees, and teaching. He/she will be expected to obtain and maintain intramural and extramural grant funding in support of research activities, or to have national prominence as an educator in the field of geriatrics. He/she will be eligible for an academic appointment at Oregon Health and Science University, commensurate with experience and qualification.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: Department of Veterans Affairs Qualifications Standards (VA Handbook 5005, Part II, Appendix G2) for AD/VM-602 series applies and may be reviewed in the Human Resources Management Service Office.

- Must be a citizen of the United States.
- Must have a Degree of doctor of medicine or an equivalent degree resulting from a course of education in medicine or osteopathic medicine.
- Must provide evidence of an active, current, full and unrestricted license to practice Medicine or Surgery in a State, Territory or Commonwealth of the U.S. or the District of Columbia.
- Must be board-certified or board eligible in internal medicine.
- Must have passed the Certification Exam in Geriatric Medicine and received a Certificate of Added Qualification (CAQ)

CONDITIONS OF EMPLOYMENT:

- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited

circumstances where there are no qualified citizens available for the position.

- All information submitted to this VA Medical Center is subject to verification by VetPro.
- If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.
- A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.
- Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.
- Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
- Relocation incentive may be authorized.
- Recruitment incentive may be authorized.
- A drug test may be required for an applicant who is tentatively selected.
- A pre-employment physical examination will be required for an applicant who is tentatively selected.
- Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).

APPLICANT'S PLEASE NOTE:
