

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement.
- Any US Citizen

MAJOR DUTIES:

The incumbent has a full time responsibility for providing pharmaceutical care to optimize patient response and resource utilization for professional staff. The incumbent evaluates provider orders/prescriptions. Monitors on an ongoing basis therapeutic outcomes, adverse effects and adherence and compliance. Analyzes laboratory data to guide therapeutic recommendations and treatment goal planning. Takes appropriate measures to ensure continuity of care for those patients who are followed at PVAMC, affiliated clinics and other VA facilities. Interviews patients to determine medication history for potential drug interactions, therapeutic duplications, efficacy of current medications regimens, compliance/adherence patterns and drug reactions.

- Acts to resolve identified problems.
- Reviews available medication profiles for appropriateness, contraindications to drug use, side effects, relevant laboratory data, evidence of drug use/misuse/abuse, compliance, patient education needs, therapeutic duplication, poly-pharmacy, allergies, adverse drug reactions, drug-drug interactions, drug-food interactions, and cost-minimization.
- Identifies drug-induced problems that may be affecting the patient and communicates these findings to the patient's primary provider/treatment team.
- Recommends therapeutic alternatives based upon the patient care assessment and desired outcome, drug safety and efficacy data, Pharmacy Benefits Management (PBM) initiatives, and other formulary management principles.
- Age/gender specific monitoring of therapy shall include review for poly-pharmacy, dose adjustments, and appropriateness of therapy.
- Participates in medication reconciliation and documents activities.
- Extends medications as needed for continuity of care (Scope of Practice/Approved Protocol required).

QUALIFICATION REQUIREMENTS:

Eligibility: Department of Veterans Affairs Qualifications Standards (VA Handbook 5005, Part II, Appendix G15) for GS-660 Series applies and may be reviewed in the Human Resources Management Service Office.

Basic Requirements

- Must be a citizen of the United States.
- Graduate of a degree program in pharmacy from an approved college or university. The degree program must have been approved by the American Council on Pharmaceutical Education (ACPE)
- Must be a full, current and unrestricted licensed pharmacist licensed to practice pharmacy in a State, Territory, Commonwealth of the United States (i.e., Puerto Rico), or the District of Columbia with at least one year of professional experience at the next lower grade or equivalent experience in private sector.

- Graduates of foreign pharmacy degree programs meet the educational requirement if their degree is found to be equivalent to degree programs recognized by the ACPE. This finding may be based on any of the following:
 - a) A letter of acceptance into a U.S. graduate pharmacy program recognized by the ACPE.
 - b) Written certification from the Foreign Pharmacy Graduate examination Commission, 700 Busse Highway, Park Ridge, IL 60068 Phone (847) 698-6227, that the individual has successfully passed the Foreign Pharmacy Graduate Examination.
 - c) A letter from a U.S. college or university with a pharmacy degree program recognized by ACPE stating that the individual's foreign pharmacy degree has been evaluated and found to be equivalent to its Bachelor of Pharmacy degree.
- A valid Oregon/Washington driver's license is required.
- Applicants must be able to distinguish basic colors.
- Applicants must be able to distinguish shades of colors.

I. **Specialized Experience:** Specialized experience is defined as previous experience processing both inpatient and outpatient prescriptions which includes the interpretation, dispensing, monitoring, counseling, and consulting for IV, Unit Dose, and outpatient prescriptions. As well, the completion of the equivalent of 1 year of creditable experience at the next lower grade level which is directly related to the position to be filled.

BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

Applicants must demonstrate through their experience or education that they possess the following published KSAs(from VA Handbook 5005) for the grade at which they wish to apply (and grades below that grade if applicable). Failure to respond to rating factors may result in your application receiving a less than desirable rating:

1. In depth knowledge of a specialized area of clinical pharmacy practice or a specialty area of pharmacy such as quality assurance/utilization review, ADP systems, drug information, etc.;
2. Advanced knowledge of pharmaceuticals, pharmacokinetics, pharmacodynamics, and pharmacotherapeutics;
3. Skill in monitoring and assessing the outcome of drug therapies including physical assessment and interpretation of laboratory and other diagnostic parameters;
4. Knowledge of the design, conduct, and interpretation of controlled clinical drug trials or other research related to health care;
5. Ability to communicate orally and in writing with a wide variety of individuals. This would typically include beneficiaries, professionals in other health care disciplines, and health related groups in the community; and
6. Knowledge of the standards related to distribution and control of scheduled and non-scheduled drugs (including research and investigational drugs.) This includes, but is not limited to, the standards established by DEA, FDA, VA, the State (Territory or District of Columbia, if appropriate), and JCAHO.

CONDITIONS OF EMPLOYMENT:

- This is an Excepted Appointment. Excepted service positions have been excepted from the requirements of the competitive service by law, Executive Order, or by OPM regulation (5 USC 2103 and 5 CFR part 213).
- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
- Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.
- All information submitted to this VA Medical Center is subject to verification by VetPro.
- If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.
- A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.
- Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.
- A drug test may be required for an applicant who is tentatively selected.
- A pre-employment physical examination will be required for an applicant who is tentatively selected.
- Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).

APPLICANT'S PLEASE NOTE:
