WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees, Veteran's Canteen Service and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement.
- Any US Citizen
- **First consideration date is 09/07/2010.** After the first consideration date, applications will then be referred in intervals. If the position is filled before the closing date the vacancy will be closed.

MAJOR DUTIES:

The incumbent is assigned as a clinician with supervisory responsibilities to the Clinical Hospitalist Service of the Section of General Internal Medicine. The incumbent will work as a hospitalist providing direct care to patients on the inpatient medical service, as well as consultative and co-managed care for patients on the inpatient surgery, psychiatry, or neurology services. The incumbent may also provide temporary outpatient care for some patients during the transitional phase from acute inpatient care back to a stable outpatient environment. The position will require night and weekend responsibilities. Depending on the incumbent's interests and skills, opportunities for the teaching and supervision of medical residents, medical students, nurse practitioners, and/or physician assistants may be available. The incumbent may also participate in administrative and quality improvement activities.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

<u>Eligibility</u>: Department of Veterans Affairs Qualifications Standards (VA Handbook 5005, Part II, Appendix G2) for AD/VM-602 series applies and may be reviewed in the Human Resources Management Service Office.

- Must be a citizen of the United States.
- Must have a Degree of doctor of medicine or an equivalent degree resulting from a course of education in medicine or osteopathic medicine.
- Must provide evidence of an active, current, full and unrestricted license to practice Medicine or Surgery in a State, Territory or Commonwealth of the U.S. or the District of Columbia.
- Must be board-certified or board eligible in Internal Medicine.

CONDITIONS OF EMPLOYMENT:

- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.
- All information submitted to this VA Medical Center is subject to verification by VetPro.
- If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.
- A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

- Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
- Recruitment incentive may be authorized.

- Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).
