

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Any US Citizen

MAJOR DUTIES:

Acts as the LPN and Clerical staff team leader. Supports and advocates for staff in order to identify staff needs and patient care issues. Accountable for day to day flow of clinics, administrative efficiencies, and safe patient care/staff ratios. Demonstrates knowledge and competency in general VA processes and information management. Acts as a consultant to new LPN and Clerical staff when questions arise regarding clinic processes. Orients patients, visitors, and new staff to the Specialty Clinics in order to maintain safety, assure clinic efficiencies, and care partnering with patients and their families. Is self directed in delivering individualized Medical Assistive care to adult and elderly patients as well as specializing in specialty clinic patient populations. Under the direction of the team RN, Physician, and/or ANP, performs a variety of routine and complex patient care activities based on the needs of the Specialty Clinic(s) and their unique patient population needs. Works collaboratively with Clinic Leadership in performance improvements and making change. Observes clinical care needs as well as the administrative functions of the clinic. Sets priorities appropriately and in a timely fashion. Provides recommendations for improvements. Utilizes standard precautions in all patient care activities. Performs a range of monitoring activities which include vitals signs, presenting complaint, pain data, and appropriate specialty check in activities such as CBG, uroflow, bladder scan, EKG, pulse oximetry, and nebulizer treatments. Assists LPN and Clerical staff identify learning needs and maintain competencies. Demonstrates skill and knowledge of specialized clinic procedures. Demonstrates effective communication, collaboration, and customer service to patients, families and coworkers. (both verbal and written) Fosters team spirit and camaraderie among clinic staff and Multidisciplinary staff. Acts as an integral member of the Specialty Clinic Multidisciplinary team and Clinic Leadership in order to foster continuity of care, enhance quality, improved clinical and administrative outcomes. Identifies areas for improvement and acts as a change agent in performance improvements both informally and formally. Performs other duties as assigned.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: Department of Veterans Affairs Qualifications Standards (VA Handbook 5005, Part II, Appendix G13) applies and may be reviewed in the Human Resources Management Service Office.

Basic Requirements:

- Must be a U.S. citizen.
- Full active, current and unrestricted licensure as a graduate licensed practical or vocational nurse in a state, territory, or commonwealth (i.e., Puerto Rico) of the United States, or District of Columbia.
- Graduate of a school of practical or vocational nursing approved by the appropriate State accrediting agency and/or the National League of Nursing at the time the program was completed by the applicant.
- Licensed practical or vocational nurses appointed to direct patient care positions must be proficient in (both) spoken and written English as required by 38 USC 7402(d), and 7407(d).

***Specialized Experience:**

For GS-5, GS-6 OR GS-7 positions one-year experience at the next lower level is required.

CONDITIONS OF EMPLOYMENT:

This is an Excepted Appointment. Excepted service positions have been excepted from the requirements of the competitive service by law, Executive Order, or by OPM regulation (5 USC 2103 and 5 CFR part 213). Public law No. 108-170 converts this occupational series from the competitive civil service to the Hybrid Title 38 employment system.

Applicants without prior federal service will be appointed at step one of the grade

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for

civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

All information submitted to this VA Medical Center is subject to verification by VetPro.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.

Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

The applicant selected for this position will be eligible to apply for an education loan reimbursement award under the provisions of the Education Debt Reduction Program (EDRP).

Applicants selected for this position may be appointed to a temporary appointment, NTE 13 months, pending completion of boarding process.

This is a developmental position. If selected below the target level, employee may be promoted without further competition upon satisfactory completion of qualification and eligibility requirements.

A drug test may be required for an applicant who is tentatively selected.

A pre-employment physical examination will be required for an applicant who is tentatively selected.

Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).
