

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Any US Citizen

MAJOR DUTIES:

The incumbent is assigned as a clinician-educator or clinician-researcher to the Cardiology Section and will take specialty call for the Section approximately 7-8 weeks per year. In addition the incumbent will be the cardiology attending in the Medical Intensive Care (MICU) for 3 to 5 two week blocks per year during which time s/he will be responsible for the care of all cardiac patients in the MICU. The incumbent will lead the Cardiology consult service for between 4 and 6 two week blocks per year, taking responsibility for evaluating and managing cardiovascular problems in all inpatients at the Portland VA Medical Center outside the medical intensive care unit. The incumbent will conduct bedside teaching with Internal Medicine House Officers on a daily basis during MICU or Consult Service rounds, as well as supervise them in the performance and interpretation of bedside procedures, ECG reading and exercise tests. The incumbent will also supervise Cardiology Fellows in the performance and interpretation of cardiac procedures and will be expected to contribute time to didactic teaching of medical students, Medical House Officers and Cardiology Fellows. The incumbent will have procedural responsibilities in addition to the inpatient care responsibilities. In particular we are seeking someone with strong non-invasive skills who can perform and interpret transeophageal echoes, interpret echo contrast studies and stress echo studies as well as read transthoracic echoes. Other activities will be tailored to fit the incumbent's clinical interests and strengths. Ability to perform diagnostic cardiac catheterizations is desirable. Duties will also involve outpatient clinical activity, including supervising and seeing patients in general cardiology clinics. In this regard, training and interest in Heart Failure care would be particularly desirable. The VA cardiology section participates actively in research activities, both involving individual basic and clinical grant funding as well as in clinical trials and other clinical research. The incumbent will be expected to participate in research activities in one or more of these broad areas. The incumbent may also be assigned administrative, managerial, quality management or quality of care responsibilities through participation in clinical and educational administrative committees, task groups or special work groups within the medical center.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: Department of Veterans Affairs Qualifications Standards (VA Handbook 5005, Part II, Appendix G2) for AD/VM-602 series applies and may be reviewed in the Human Resources Management Service Office.

- Must be a citizen of the United States.
- Must have a Degree of doctor of medicine or an equivalent degree resulting from a course of education in medicine or osteopathic medicine.
- Must provide evidence of an active, current, full and unrestricted license to practice Medicine or Surgery in a State, Territory or Commonwealth of the U.S. or the District of Columbia.
- Must be board-certified or board eligible in Internal Medicine as well as Cardiovascular Disease.

CONDITIONS OF EMPLOYMENT:

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

A security clearance and a favorable suitability determination are required.
