

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Any US Citizen

MAJOR DUTIES:

The Staff Anesthesiologist has responsibility for providing the complete range of anesthetic care of patients including preoperative assessment, intra-operative anesthetic administration and monitoring, post-anesthesia care, and intensive care unit care in compliance with national (JCAHO) accreditation standards. Incumbent is accountable to Chief, Anesthesiology Service, to provide the most effective delivery of anesthetic care throughout the medical center while meeting and exceeding compliance standards. Provides anesthesia-related direct patient care in all functional areas of the OR, ICU, ward, and clinic settings as needed, to include on-call coverage. Provides anesthesia-related training to qualified residents and students in these settings in accordance with supervision policies and procedures. In addition provides critical care related direct care as part of a multidisciplinary critical care team.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: Department of Veterans Affairs Qualifications Standards apply (VA Handbook 5005, Part II, Appendix G2) and may be reviewed in the Human Resources Management Service Office.

- Must be a citizen of the United States.
- Must have a Degree of doctor of medicine or an equivalent degree resulting from a course of education in medicine or osteopathic medicine.
- Must provide evidence of an active, current, full and unrestricted license to practice Medicine or Surgery in a State, Territory or Commonwealth of the U.S. or the District of Columbia.
- Must be board-certified or board eligible in Anesthesiology with additional eligibility or certification in Critical Care through the American Board of Anesthesiology.
- Subspecialty training, previous staff experience with complex anesthesiology and critical patient care and demonstrated supervisory skills are desirable but not requisite.

CONDITIONS OF EMPLOYMENT:

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

All information submitted to this VA Medical Center is subject to verification by VetPro.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited

Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

The full-time applicant selected for this position will be eligible to apply for an education loan reimbursement award under the provisions of the Education Debt Reduction Program (EDRP).

Recruitment or relocation incentive may be authorized.

A drug test may be required for an applicant who is tentatively selected.

A pre-employment physical examination will be required for an applicant who is tentatively selected.

Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).

APPLICANT'S PLEASE NOTE:
