

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Any US Citizen

Applicants who applied under announcement T38H-07-768-DR need not reapply as they will be considered under this announcement.

MAJOR DUTIES:

The incumbent shares program coordination responsibilities with the Contract Adult Day Health Care (CADHC) RN Program Coordinator, including staff education regarding CADHC services and referral processes, the development, evaluation and communication of standards, policies and procedures, and plans of care in the CADHC program, the identification, development, and oversight of program resources in the community, liaison with community resources, as well as participation in research, research utilization, and program development. The incumbent will make visits to clients in home settings to evaluate their need for CADHC services. The social worker will also make visits to clients in ADHC settings to evaluate the appropriateness of services provided, need for ongoing services, and/or need for transfer to an alternate level of care. The incumbent will provide veterans in the CADHC Program with high quality case management, clinical treatment, advocacy, and linkage with appropriate VA and community service providers/agencies as needed by the client. This is accomplished in collaboration with other members of the CADHC team or other interdisciplinary treatment teams as appropriate (i.e. Specialty Clinics, NSCU, primary care, mental health, etc.).

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: U.S. Office of Personnel Management Qualification Standards Handbook and VA Handbook 5005, Pt II, Appendix F7 for GS-185 series applies and may be reviewed in the Human Resources Management Service office. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.

Basic Requirements: Master's degree in Social Work from a school of Social Work accredited by the Council on Social Work Education. All candidates must possess a state license, certification or registration to practice social work. If the successful applicant is not licensed at the time of appointment, s/he must be licensed or certified at the Master's level, within 3 years of his/her appointment as a social worker or 1 year from the day s/he meets the full requirements of the state for licensure or certification, whichever is longer. Individuals who fail to obtain licensure and/or certification within the allotted time will be removed from the GS-185 series. This may result in termination of employment. Please submit a copy of your college transcripts with application packet.

Specialized Experience: One (1) year experience that equipped the applicant with the particular knowledge, skills, and abilities (KSA's) to perform successfully the duties of the position, and that is typically in or related to the work of the position to be filled. To be creditable, specialized experience must have been equivalent to at least the next lower grade level.

BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to rating factors will result in applicant not being referred for the position:

1. Ability to develop and maintain effective relationships with patients, family, staff, and community resources

2. Knowledge and ability to apply principles and theoretical concepts of social work to a specific patient population including the ability to apply the social work code of ethics in daily practice.
3. Ability to select the pertinent techniques for data collection.
4. Ability to communicate both orally and in writing with healthcare providers and administrative staff.
5. Ability to work effectively in an interdisciplinary patient care program
6. Knowledge of medical diagnoses, including COPD, CHF, and Diabetes, and their impact on the psychosocial functioning of the patient and family.

CONDITIONS OF EMPLOYMENT:

This is an Excepted Appointment. Excepted service positions have been excepted from the requirements of the competitive service by law, Executive Order, or by OPM regulation (5 USC 2103 and 5 CFR part 213). Public law No. 108-170 converts this occupational series from the competitive civil service to the Hybrid Title 38 employment system.

Applicants without prior federal service will be appointed at step one of the grade

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

All information submitted to this VA Medical Center is subject to verification by VetPro.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 USC 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.

Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

A pre-employment physical examination will be required for an applicant who is tentatively selected.

Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38USC 7402(d) and 7407(d).
