MAJOR DUTIES:

The incumbent provides technical writing expertise relating to Quality Management business for the Medical Center, the Q&P Chief, and all Quality Consultants. Provides training and/or training coordination expertise as it relates to Quality Management business for the Medical Center, the Q&P Chief, and all Quality Consultants. Provides follow-up and problem resolution support as it relates to Quality Management business for the Medical Center, the Q&P Chief, and all Quality Consultants. Provides consultative support in planning, designing and implementation of process improvements and other policy-making activities.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: U.S. Office of Personnel Management Qualification Standards Handbook for GS-343 series applies and may be reviewed in the Human Resources Management Service office. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.

Specialized Experience: 1 year of experience that equipped the applicant with the particular knowledge, skills, and abilities to perform successfully the duties of the position, and that is typically in or related to the work of the position to be filled. To be creditable, specialized experience must have been equivalent to at least the next lower grade level in the normal line of progression for the occupation in the organization.

Substitution of Education for Experience: Ph.D. or equivalent doctoral degree or 3 full years of progressively higher level graduate education leading to such a degree or LL.M., if related. If using education as a substitute for experience, please submit a copy of your college transcripts with application packet.

The preferred applicant will have a knowledge and experience with MS Word, Access, Visio, Excel, Technical writing experience, and training experience.

BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to rating factors will result in applicant not being referred for the position:

1. Knowledge and skill in applying analytical and evaluative methods and techniques to issues or studies concerning the efficiency and effectiveness of program operations.
2. Skill in conducting detailed analyses of complex functions and work processes.
3. Excellent oral and written communication skills.
4. Experience with database entry and maintenance.
5. Experience training end users in both an individual and classroom setting.
6. Technical writing experience converting complex information into user-friendly terminology.
