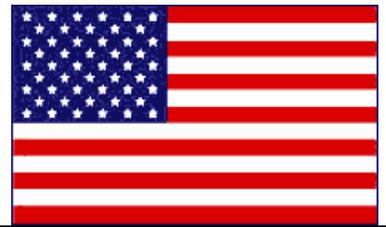

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.

MAJOR DUTIES:

The incumbent serves as a personal assistant to the Chief of Police with a police department of 35 FTEE for a Level 2 Tertiary facility staffed with over 3000 employees in full time, part time and intermittent appointments. Provides contact support services such as answering the telephone, referring visitors, or providing information about the office, its functions, and standard operating procedures, as well as similar information. Reads incoming correspondence, publications, regulations, and directives which may affect the Service. Prepares purchase requests for equipment approved by the Chief of Police or designee. Manages and maintains all files within Police Service and ensures filing system is arranged according to guidance from central office.

THIS POSITION IS EXCLUDED FROM THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: U.S. Office of Personnel Management Qualification Standards Handbook for GS-318 series applies and may be reviewed in the Human Resources Management Service office. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.

Specialized Experience: One (1) year of specialized experience equivalent to the next lower grade. Experience must have equipped the applicant with the particular knowledge, skills, and abilities to perform successfully the duties of the position and that are typically in or related to the work of the position. To be creditable, specialized experience must have been equivalent to at least the next lower grade level.

Substitution of Education for Experience: As a general rule, education is not creditable above GS-5 for most positions covered by this standard; however, graduate education may be credited in those few instances where the graduate education is directly related to the work of the position.

BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to rating factors will result in applicant not being referred for the position:

1. Describe the computer software you utilize (i.e. Microsoft Office Products or other software associated with clerical duties).
2. Knowledge of standardized rules, procedures, or operations to perform the full range of standard clerical assignments such as document preparation, filing systems, and phone protocol.
3. Ability to handle a diverse group of individuals (veterans, their representatives, visitors, and all VA staff) with tact and diplomacy in a courteous and respectful manner. Some of the individuals could be agitated and/or confrontational.
4. Skill in handling multiple tasks and ability to determine priority based on the needs of the service.

CONDITIONS OF EMPLOYMENT:

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future. Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion. Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.
