

### WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees and permanent Title 38 Hybrid employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Career or career conditional employees and permanent Title 38 employees of other VA facilities.
- Applicants with competitive status outside the VA i.e., those with transfer or reinstatement eligibility.
- Veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after 3 or more years of continuous active service.
- Employees covered under the provision of the inter-agency Career Transition Plan (ICTAP) and Career Transition Assistance Plan (CTAP) (displaced VA Employees) eligibles will be given priority consideration for vacancies within the **local commuting area** for which they are well qualified. Applicants requesting this consideration must attach appropriate proof of the ICTAP eligibility with their application.

**Applicants who applied under announcement 3W-07-632-TN need not reapply as they will be considered under this announcement.**

### MAJOR DUTIES:

The incumbent receives requests or instructions for procedures. Secures patients' confidence and cooperation during procedures. Determines technical factors, sets controls and operates equipment and instruments. Assists medical staff with or performs diagnostic procedures used to diagnose medical conditions. Performs range of diagnostic support duties such as taking, recording and reporting to supervisor deviations in vital signs, taking specimens, labeling specimens for the laboratory. Provides general clerical/administrative support coordination work for the unit. Assembles patient records. Receives and directs patients, answers routine inquiries and makes referrals. Performs direct patient support work including personal patient care. Teaches patients and family members the necessity of continuing proper health care. Performs administrative tasks such as maintaining control records for specimens and tests documenting measurements taken. Performs patient care procedures such as collections of specimens, applying dressings, adjusting simple supportive equipment.

### **THIS POSITION IS IN THE BARGAINING UNIT**

### QUALIFICATION REQUIREMENTS:

**Eligibility:** U.S. Office of Personnel Management Qualification Standards Handbook for GS-640 series applies and may be reviewed in the Human Resources Management Service office. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.

**Specialized Experience:** At least one year of specialized experience comparable to the next lower level in the Federal Service. Experience must have been related to the work of the position for which application is made.

**Substitution of Education for Experience:** If using education as a substitute for experience, please submit a copy of your college transcripts with application packet. **GS-6** requires one full year of graduate education.

### BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

**On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to rating factors will result in applicant not being referred for the position:**

1. Ability to provide patient care functions such as blood pressures, temperatures, pulse, dressing changes, personal care and injections.
2. Excellent customer service to effectively communicate with patients, family members and all hospital staff in clerical and clinic support roles.

3. Knowledge of patient care equipment use and terminology to include EKG, CBG, blood pressure machine and pulse oximetry.
4. Ability to use computer to check patients in and out of clinic and schedule appointments.
5. Knowledge of standard medical terminology
6. Ability to prioritize and complete multiple tasks in assigned time frame.

### **CONDITIONS OF EMPLOYMENT:**

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Applicants without prior federal service will be appointed at step one of the grade

Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus

A drug test may be required for an applicant who is tentatively selected.

A pre-employment physical examination will be required for an applicant who is tentatively selected.
