

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees and permanent Title 38 Hybrid employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Career or career conditional employees and permanent Title 38 employees of other VA facilities.
- Applicants with competitive status outside the VA i.e., those with transfer or reinstatement eligibility.
- Veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after 3 or more years of continuous active service.
- Employees covered under the provision of the inter-agency Career Transition Plan (ICTAP) and Career Transition Assistance Plan (CTAP) (displaced VA Employees) eligibles will be given priority consideration for vacancies within the local commuting area for which they are well qualified. Applicants requesting this consideration must attach appropriate proof of the ITCAP eligibility with their application.

MAJOR DUTIES:

This position is required to perform scheduled maintenance and inspections on building service equipment and personal property throughout the Medical center complex- The principle task t a inspect, clean, replace, adjust and lubricate worn or faulty systems and components before the system or equipment fails; causing lengthy downtimes and/or repairs. Types of equipment worked on are: hydraulic: beds, lifts, loading dock ramps, valves and pumps; electrical: motors, motor starters and controls, relays, solenoid valves, baking ovens, and time switches; diesel generators, medical and dental vacuum pumps. Common tools used are pressure vacuum gauges, ultra sound add .infrared test equipment, dial indicators, micrometers, arc and gas welders, multimeters, ammeters, lathes, drill presses, air compressors, hydraulic presses, chain hoists, steam cleaners, sanders, bearing pullers and all work hand tools and installing tools- All work and tool use will be done in a safe manner in accordance with VA and Medical Center guidelines as published. Performs duties in a professional manner, maintaining decorum with all Personnel. Mechanic also tests water backflow preventers. Duties include, but are not limited to knowledge of various high pressure piping systems and equipment, such as vacuum systems, and circulating pumps. Knowledge of relief valves, check valves, pressure regulators, tanks, heat exchangers and associated equipment as required. Must have the skill to identify malfunctioning components, determine method of repair, and repair by cleaning, adjusting, rebuilding or replacement of the component. Must be able to use shop mathematics, figuring pipe, joint and valve sizes, type of pipe to use and support required, Aligns fittings and joints for accurate match and to insure a leak free system under various pressures.

QUALIFICATION REQUIREMENTS:

Eligibility: U.S. Office of Personnel Management Qualifications Standards for WG-4749 series applies and may be reviewed in the Human Resources Management Division office. There is no specific amount of experience and/or training required, but candidates must demonstrate via their experience or combination of experience/training that they possess the knowledge, skills, and abilities required for the position (see "Basis of Rating" below).

BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to rating factors will result in applicant not being referred for the position:

1. Describe your mechanical and maintenance experience as it relates to various systems such as deionized and reverse osmosis water.
2. Describe your mechanical and maintenance experience as it relates to various piping systems and individual components such as pumps, repair and replacement of various metal pipes, sleeves, bearings, seals and packing.

3. Describe your customer service (users, contractors, staff and co-workers) experience.
4. Describe your installation and maintenance experience as it relates to all piping systems such as plumbing, steam, gas, air, medical gases and water.
5. This position description entails emergency service calls. Describe your ability to respond to such calls.

CONDITIONS OF EMPLOYMENT:

- Applicants without prior federal service will be appointed at step one of the grade
- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
- Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.
- If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.
- A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.
- Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.
- A pre-employment physical examination will be required for an applicant who is tentatively selected.
- This agency provides reasonable accommodations to applicants with disabilities. If you need a reasonable accommodation for any part of the application and hiring process, please notify the agency. The decision on granting reasonable accommodation will be on a case-by-case basis

APPLICANT'S PLEASE NOTE:
