WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.

MAJOR DUTIES:

This position is located in the Billing section of the Revenue Office in Portland, Oregon within VISN 20. This position is responsible for contacting all insurance carriers to verify enrollee benefits. The Veteran's insurance information is reviewed and updated continuously using the VISTA program. On a daily basis the incumbent will utilize the insurance database buffer files, copies of insurance cards, VA insurance request forms, and memos from staff personnel to gather insurance information. The incumbent supports the Outpatient Pharmacy Electronic Claims Coordinator (OPECC) by loading all pertinent information required to send an electronic claim.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: U.S. Office of Personnel Management Qualification Standards Handbook for GS-303 series applies and may be reviewed in the Human Resources Management Service office. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.

Specialized Experience: At least one (1) year of specialized experience equivalent to the next lower grade. Experience must have equipped the applicant with the particular knowledge, skills, and abilities to perform successfully the duties of the position and that are typically in or related to the work of the position. To be creditable, specialized experience must have been equivalent to at least the next lower grade level.

Substitution of Education for Experience: Successful completion of four (4) years above high school education. This education must have been obtained in an accredited business, secretarial or technical school, junior college, college or university. If using education as a substitute for experience, please submit a copy of your college transcripts with application packet.

BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to rating factors will result in applicant not being referred for the position:

1. Knowledge of medical insurance terms, abbreviations, and benefits.
2. Interviewing skills in order to extract complete and accurate information from insurance company representatives.
3. Ability to communicate across all age ranges and socioeconomic levels.
4. Ability to access various website to determine eligibility and verify insurance coverage.
5. Knowledge of veterans eligibility and third party payer as they related to insurance verification.

CONDITIONS OF EMPLOYMENT:

- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
- Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.
