### WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees and permanent Title 38 Hybrid employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Career or career conditional employees and permanent Title 38 employees of other VA facilities.
- Applicants with competitive status outside the VA i.e., those with transfer or reinstatement eligibility.
- Veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after 3 or more years of continuous active service.
- Employees covered under the provision of the inter-agency Career Transition Plan (ICTAP) and Career Transition Assistance Plan (CTAP) (displaced VA Employees) eligibles will be given priority consideration for vacancies within the **local commuting area** for which they are well qualified. Applicants requesting this consideration must attach appropriate proof of the ICTAP eligibility with their application. Well qualified is defined as an applicant, without any further training, can perform the major duties of the position which include proficient knowledge and interpretation of regulations regarding eligibility for VA Medical care, extensive experience in assuring compliance with all procedural policies and directives with effective skills in leading a team of employees.

### MAJOR DUTIES:

Incumbent serves as a Lead Enrollment Specialist of the Business Office at the VA Medical Center, Portland, Oregon. The Enrollment Office encompasses the following functions: Patient Enrollment, Eligibility, Verification, Beneficiary Travel, Patient Funds, Admissions. The incumbent will lead a team of 8 or more Enrollment Specialists and must be able to perform all of the duties of an enrollment specialist, including ensuring that all work assignments of other employees in unit are carried out by performing a range of duties that include, but are not limited to; distributing and balancing workload among employees in established work flow and rotation schedule. Ensuring timeliness and completion of competing priorities. Training and review of new employees on given tasks in accordance with established procedures and practices. Ability to interpret government laws, regulations, and processes in accordance with processes and procedures. The incumbent has the knowledge and ability to locate, extract, and present information in clear and effective language so decisions may be made to best achieve facility goals.

### **THIS POSITION IS IN THE BARGAINING UNIT**

### QUALIFICATION REQUIREMENTS:

**Eligibility:** U.S. Office of Personnel Management Qualification Standards Handbook for GS-303, Clerical and Administrative Support positions, series apply and may be reviewed in the Human Resources Management Service office. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.

**Specialized Experience:** At least one (1) year of specialized experience that equipped the applicant with the particular knowledge, skills, and abilities (KSA's) to successfully perform the duties of the position, and that is typically in or related to the position to be filled. To be creditable, specialized experience would include positions such as Executive Assistants, Customer Service Representative, Public Relations positions for large complex organizations and/or advanced Clerical positions that handle high call and customer service volume.

**Substitution of Education for Experience:** GS-7, Generally not applicable.

### BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

1. Proficient knowledge of policies, procedures and regulations pertaining to eligibility and entitlement for benefits.

2. Ability to demonstrate good judgment and logic in solving problems and function independently.
3. Ability to plan, organize and adjust to competing priorities and workloads and working with various personnel and offices to following through with completion of tasks.
4. Demonstrated skill in interpersonal relationships, telephone etiquette and dealing with the public with positive and effective customer service.

#### **CONDITIONS OF EMPLOYMENT:**

- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Applicants without prior federal service will be appointed at step one of the grade
- Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
- Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.
- If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.
- A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.
- Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.
- Employee selected must serve a one (1) year probationary period for managers/supervisors as contained in 5 USC 315, unless she/he has already served the required supervisory period.
- Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).
- This agency provides reasonable accommodations to applicants with disabilities. If you need a reasonable accommodation for any part of the application and hiring process, please notify the agency. The decision on granting reasonable accommodation will be on a case-by-case basis
