

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees and permanent Title 38 Hybrid employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Career or career conditional employees and permanent Title 38 employees of other VA facilities.
- Applicants with competitive status outside the VA i.e., those with transfer or reinstatement eligibility.
- VEOA (Veterans Employment Opportunities Act) Veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after 3 or more years of continuous active service.
- Employees covered under the provision of the inter-agency Career Transition Plan (ICTAP) and Career Transition Assistance Plan (CTAP) (displaced VA Employees) eligibles will be given priority consideration for vacancies within the **local commuting area** for which they are well qualified. Applicants requesting this consideration must attach appropriate proof of the ITCAP eligibility with their application. Well qualified is defined as an applicant, without any further training, can perform the major duties of the position which include managing and controlling the non-expendable property program and accounting system, maintaining an accurate accounting of physical inventory for PVAMC & CBOC's, performing property accountability duties or the more routine phases of property management including inventory of nonexpendable property, and reporting excess property, processing supply transactions such as receipt, shipment, and/or adjustment documents, preparing item descriptions for new items entering supply channels or performing work involved in the publication of stock lists, performing inventory management related duties including elements of item management, and materiel coordination, and inventory control.

MAJOR DUTIES:

Incumbent has the responsibility for the management and control of the non-expendable property program and accounting system and is responsible for the physical inventory for PVAMC, CBOC's, VISN, Vet Centers, Willamette National Cemetery, and Regional Office. Performs property accountability duties or the more routine phases of property management including inventory of nonexpendable property, reporting excess property, etc. Processes supply transactions such as receipt, shipment, and/or adjustment documents. Prepares item descriptions for new items entering supply channels or performs work involved in the publication of stock lists. Performs inventory management related duties including elements of item management, materiel coordination, and inventory control. Performs other related duties as assigned.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: U.S. Office of Personnel Management Qualification Standards Handbook for GS-2005, Clerical and Administrative Support Positions series apply and may be reviewed in the Human Resources Management Service office. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.

Specialized Experience: One (1) year that equipped the applicant with the particular knowledge, skills, and abilities (KSA'S) to perform successfully the duties of the position to be filled. To be creditable, specialized experience must have been equivalent to at least the next lower grade level. **GS-5 Level:** Specialized experience may include work as an Office Manager, Inventory Specialist, Supply Technician, Materials Handler, Medical Supply Technician or similar position within a medical center, hospital or clinic. Duties may have included, but are not limited to, maintaining an accurate accounting of physical inventory, performing property accountability duties or the more routine phases of property management including inventory of nonexpendable property, and reporting excess property, processing supply transactions such as receipt, shipment, and/or adjustment documents, and preparing item

descriptions for new items entering supply channels or performing work involved in the publication of stock lists. **GS-6 Level:** Specialized experience may include work as a Supply Technician, Medical Supply Technician, Materials Handler, Inventory Specialist, or similar position in a hospital, medical center or clinic. BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to rating factors may result in your application receiving a less than desirable rating:

1. Knowledge of Federal Property Management procedures.
2. Ability to communicate verbally and in writing with other employees and vendors.
3. Ability to prioritize and work under pressure.
4. Knowledge of automated supply inventory and tracking systems.
5. Ability to generate and analyze reports.

CONDITIONS OF EMPLOYMENT:

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future. Applicants without prior federal service will be appointed at step one of the grade.

Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

A pre-employment physical examination will be required for an applicant who is tentatively selected.

Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.

This is a developmental position. If selected below the target level, employee may be promoted without further competition upon satisfactory completion of qualification and eligibility requirements.

APPLICANT'S PLEASE NOTE:
