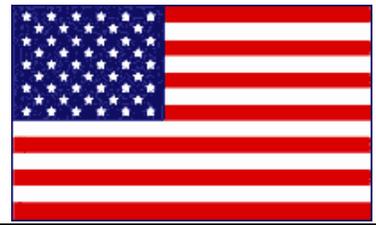

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees and permanent Title 38 Hybrid employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Career or career conditional employees and permanent Title 38 employees of other VA facilities.
- Applicants with competitive status outside the VA i.e., those with transfer or reinstatement eligibility.
- VEOA (Veterans Employment Opportunities Act) Veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after 3 or more years of continuous active service.
- Employees covered under the provision of the inter-agency Career Transition Plan (ICTAP) and Career Transition Assistance Plan (CTAP) (displaced VA Employees) eligibles will be given priority consideration for vacancies within the **local commuting area** for which they are well qualified. Applicants requesting this consideration must attach appropriate proof of the ICTAP eligibility with their application. Well qualified is defined as an applicant, without any further training, can perform the major duties of the position which include knowledge of pay regulations of various types of pay, PAID system, and ability to use the VA timekeeping system..

MAJOR DUTIES:

The primary purpose of this position is to ensure proper application of pay regulations and consistency of input for appointments, promotions, pay adjustments, reassignments, awards, and separations. The incumbent processes the payroll actions in a automated system unique to the Veterans Administration for employees appointed under three different personnel systems (Title 5, Title 38 and Non-Appropriated Fund), which have unique pay accounts. Employees are found under three retirement systems CSRS, FERS, and CSRS Offset plan; each with distinctly different contribution provisions and a Thrift Savings Plan program with different contribution provisions. There are special bonus programs and unique types of pay for multiple different occupations and categories of employment- Pay accounts can be relatively unstable requiring frequent retroactive actions involving non-standard pay and leave accrual actions that are complicated in nature. Accounts must be paid on a thoroughly current basis, with the goal of minimizing overpayment or underpayment situations. Pay accounts are handled for employees at remote locations and in two states.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: U.S. Office of Personnel Management Qualification Standards Handbook for GS-544, Accounting and Budget series apply and may be reviewed in the Human Resources Management Service office.

Specialized Experience: At least one (1) year of experience that equipped the applicant with the particular knowledge, skills, and abilities (KSA's) to perform successfully the duties of the position, and that is typically in or related to the position to be filled. To be creditable, specialized experience must have been equivalent to at least the next lower grade level. Specialized experience would include processing payroll and/or timekeeping in an automated pay system for a large organization, private or federal.

Substitution of Education for Experience: **GS-5:** Four (4) years of successfully completed education above the high school level. This education must have been obtained in an accredited business, secretarial or technical school, junior college, college or university. If using education as a substitute for experience, please submit a copy of your college transcripts with application packet. **GS-6 & GS-7:** Generally not applicable.

BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to the rating factors may result in your application receiving a less than desirable rating.

1. Knowledge of the rules, regulations, and procedures governing pay for employees involving a broad range of pay plans with differing entitlements to pay, deductions, and benefits
2. Ability to communicate in oral or in writing technical information in a tactful manner to others with varied backgrounds and levels of understanding.
3. Ability to independently organize work, establish priorities, and meet deadlines within time sensitive constraints.
4. Skill and proficiency in using word processing, databases and other automated software.

CONDITIONS OF EMPLOYMENT:

- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Applicants without prior federal service will be appointed at step one of the grade
- Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
- Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.
- If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.
- A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.
- Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.
- This is a developmental position. If selected below the target level, employee may be promoted without further competition upon satisfactory completion of qualification and eligibility requirements.
- This agency provides reasonable accommodations to applicants with disabilities. If you need a reasonable accommodation for any part of the application and hiring process, please notify the agency. The decision on granting reasonable accommodation will be on a case-by-case basis
- The United States Government does not discriminate in employment on the basis of race, color, religion, sex, national origin, political affiliation, sexual orientation, marital status, disability, age, membership in an employee organization, or other non-merit factor.
- It is the policy of the Department of Veterans Affairs that all Federal wage and salary payments are paid to employees by Direct Deposit/Electronic Funds Transfer (DD/EFT).

7. ITCAP Applicants: Submit proof by including a copy of the agency notice, most recent Performance Rating and most recent SF-50 indicating current position, grade, level, and duty station.

APPLICANT'S PLEASE NOTE:
