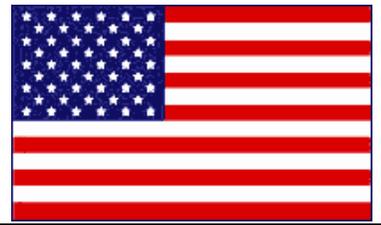

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees and permanent Title 38 Hybrid employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Career or career conditional employees and permanent Title 38 employees of other VA facilities.
- Applicants with competitive status outside the VA i.e., those with transfer or reinstatement eligibility.
- VEOA (Veterans Employment Opportunities Act) Veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after 3 or more years of continuous active service.
- Employees covered under the provision of the inter-agency Career Transition Plan (ICTAP) and Career Transition Assistance Plan (CTAP) (displaced VA Employees) eligibles will be given priority consideration for vacancies within the **local commuting area** for which they are well qualified. Applicants requesting this consideration must attach appropriate proof of the ITCAP eligibility with their application. Well qualified is defined as an applicant, without any further training, can perform the major duties of the position which include conducting cost analysis, product research and tracking for Prime Vendor, Commodity Standards Committee and standardized contracts, tracking and converting mandatory contracts, preparing required reports i.e., compliance requirements, purchasing, logistics and contracting reports, for CO, VISN and the Medical Center's executive office, serving as liaison with L&MM staff, vendors and contracting staff to facilitate the Medical Center's acquisition goals, documenting all recalls and patient safety alerts, and assisting Chief, Materiel Management and Chief, Logistics and Materiel Management with National Item File and vendor file initiatives and procedures.

MAJOR DUTIES:

Incumbent is responsible for all cost analysis, product research and tracking for Prime Vendor, Commodity Standards Committee and standardized contracts. Tracking and conversion of mandatory contracts is a primary function of this position. Incumbent is responsible for preparing required reports i.e., compliance requirements, purchasing, logistics and contracting reports, for CO, VISN and the Medical Center's executive office. Incumbent serves as a liaison with L&MM staff, vendors and contracting staff to facilitate the Medical Center's acquisition goals. The incumbent is the L&MM Recalls Manager, responsible for documenting all recalls and patient safety alerts. Incumbent's duties include being the primary backup for the L&MM GIP/Omni program. Incumbent's duties include assisting Chief, Materiel Management and Chief, Logistics and Materiel Management with National Item File and vendor file initiatives and procedures.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: U.S. Office of Personnel Management Qualification Standards Handbook for GS-2003, Supply Program Management Series, and Administrative and Management Positions series apply and may be reviewed in the Human Resources Management Service office. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.

Specialized Experience: One (1) year of experience that equipped the applicant with the particular knowledge, skills, and abilities to perform successfully the duties of the position, and that is typically in or related to the work of the position to be filled. To be creditable, specialized experience must have been equivalent to at least the next lower grade level in the normal line of progression for the occupation in the organization. Specialized experience includes, but is not limited to work as a Program Analyst, Systems Analyst or similar position in a dynamic and complex organization, agency or company. Duties may have included, but are not limited to, conducting cost analysis, product research and tracking for Prime Vendor, Commodity Standards Committee and standardized contracts, tracking and

converting mandatory contracts, preparing required reports i.e., compliance requirements, purchasing, logistics and contracting reports, for CO, VISN and the Medical Center's executive office, serving as liaison with L&MM staff, vendors and contracting staff to facilitate the Medical Center's acquisition goals, documenting all recalls and patient safety alerts, and assisting Chief, Materiel Management and Chief, Logistics and Materiel Management with National Item File and vendor file initiatives and procedures.

Substitution of Education for Experience: Master's or equivalent graduate degree or 2 full years of progressively higher-level graduate education leading to such a degree, LL.B., or J.D., if related. **If using education as a substitute for experience, please submit a copy of your college transcripts with application packet.**

BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to the rating factors may result in your application receiving a less than desirable rating.

1. Describe your expertise and ability to design and develop report formats to provide supply management information.
2. Ability to work collaboratively with the many disciplines within the Medical Center as well as representatives from various levels within the agency.
3. Ability to identify and analyze data patterns in order to make recommendations for resolutions.
4. Ability to apply VHA Acquisition regulations as they relate to meeting goals.
5. Skill in the use of database management systems and statistical analysis including the use of valid sampling techniques, applications of appropriate statistical formulae, and presentation of the information for a varied audience.
6. Skill in data report presentation, using software to produce professional results that are easy to read, interpret, and understand in both hardcopy and electronic mediums.

CONDITIONS OF EMPLOYMENT:

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Applicants without prior federal service will be appointed at step one of the grade

Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.

APPLICANT'S PLEASE NOTE:
