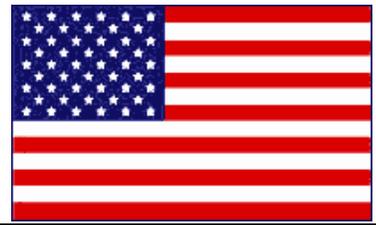

### WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees and permanent Title 38 Hybrid employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Career or career conditional employees and permanent Title 38 employees of other VA facilities.
- Applicants with competitive status outside the VA i.e., those with transfer or reinstatement eligibility.
- VEOA (Veterans Employment Opportunities Act) Veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after 3 or more years of continuous active service.
- Employees covered under the provision of the inter-agency Career Transition Plan (ICTAP) and Career Transition Assistance Plan (CTAP) (displaced VA Employees) eligibles will be given priority consideration for vacancies within the **local commuting area** for which they are well qualified. Applicants requesting this consideration must attach appropriate proof of the ICTAP eligibility with their application. Well qualified is defined as an applicant, without any further training, can perform the major duties of the position which include providing outreach to prospective clients, rendering services to clients and engaging in community networking; collaborating with other team members and with professionals, paraprofessionals, volunteers and others in VA facilities and community agencies to help veterans recognize and resolve their problems and needs; and conducting interviews and counseling with clients and families and providing psychological assessment and treatment to clients and their families.

**Applicants who applied to announcement T38-09-0231-PP will be considered under this new vacancy and need not reapply.**

**Positions may be filled as a Clinical Psychologist, Readjustment Counseling Therapist or Social Worker.**

### MAJOR DUTIES:

The incumbent serves as a Readjustment Counseling Therapist on a multidisciplinary team that is located in a community-based Vet Center that provides veterans with community outreach, counseling, therapy, treatment and direct services and referral to VA and community resources. In addition, the Readjustment Counseling Program provides community education regarding the problems and needs of the veteran. The incumbent maintains an office in the Vet Center, and provides outreach to prospective clients, renders services to clients and engages in community networking. The incumbent will collaborate with other team members and with professionals, paraprofessionals, volunteers and others in VA facilities and community agencies to help veterans recognize and resolve their problems and needs. Conducts interviews and counseling with clients and families and provides psychological assessment and treatment to clients and their families

### QUALIFICATION REQUIREMENTS:

**Eligibility:** U.S. Office of Personnel Management Qualification Standards Handbook for GS-101, Social Science Series apply and may be reviewed in the Human Resources Management Service office. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.

**Basic Requirements:** Degree: behavioral or social science; or related disciplines appropriate to the position. **-OR-** Combination of education and experience--that provided the applicant with knowledge of one or more of the behavioral or social sciences equivalent to a major in the field. **-OR-**

Four years of appropriate experience that demonstrated that the applicant has acquired knowledge of one or more of the behavioral or social sciences equivalent to a major in the field.

**Specialized Experience:** One (1) year that equipped the applicant with the particular knowledge, skills, and abilities (KSA's) to perform successfully the duties of the position to be filled. To be creditable, specialized experience must have been equivalent to at least the GS-9 level.

**Substitution of Education for Experience:** 3 years of progressively higher level graduate education leading to a PH.D. degree or PH.D. or equivalent doctoral degree. If using education as a substitute for experience, please submit a copy of your college transcripts with application packet.

**The preferred candidate will possess knowledge of and understanding of Post-Traumatic Stress Disorder (PTSD), differential diagnosis, and treatment resources specific to PTSD.**

#### **BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))**

***On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to the rating factors may result in your application receiving a less than desirable rating.***

1. Ability to conduct psycho-social assessment and implement treatment for individuals from various social-economic, cultural, and ethnic backgrounds.
2. Ability to provide clinical services on a multi-disciplinary team.
3. Ability to establish and maintain referral networks through community outreach.
4. Knowledge of and understanding of Post-Traumatic Stress Disorder (PTSD), differential diagnosis, and treatment resources specific of PTSD.
5. Ability to conduct family and group therapies.

#### **CONDITIONS OF EMPLOYMENT:**

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future. Applicants without prior federal service will be appointed at step one of the grade.

Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.

Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).
