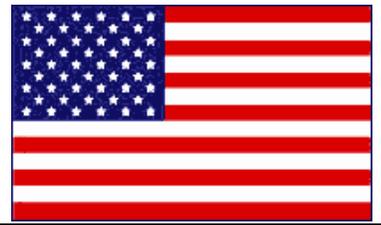

### WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees and permanent Title 38 Hybrid employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.

### MAJOR DUTIES:

Serves in a pivotal administrative position and is the senior assistant processing all the clinical administrative details for patients assigned to the Outpatient Mental Health Access Clinic (MAC). Incumbent is seen as the on-the-spot expert for expediting administrative procedures to allow for efficient patient care and a liaison to work with a variety of clinical health care providers. Responds to questions from patients/staff from other services concerning mental health services. Provides administrative functions for the MAC clinic as well as some ER and inpatient Psychiatry support. Handles established requirements for training clerical employees and giving orientation to rotating residents and interns. Performs other related duties as assigned.

### QUALIFICATION REQUIREMENTS:

**Eligibility:** U.S. Office of Personnel Management Qualification Standards Handbook for GS-303, Clerical and Administrative Support Positions series apply and may be reviewed in the Human Resources Management Service office. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.

**Specialized Experience:** One year of experience that equipped the applicant with the particular knowledge, skills, and abilities (KSA's) to perform successfully the duties of the position, and that is typically in or related to the position to be filled. To be creditable, specialized experience must have been equivalent to at least the next lower grade level.

### BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

**On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to the rating factors may result in your application receiving a less than desirable rating.**

1. Ability to generate, review, and analyze statistical data reports for omissions and inconsistencies ensuring that data entry is timely, complete and accurate.
2. Strong skills and ability to use Microsoft Excel including Excel's charting and graphing functions. Knowledge and experience using Microsoft Access database program and Microsoft Word.
3. Knowledge of mental health ICD-9 coding conventions. Knowledge of CPRS clinical reminders and accompanying VISTA applications.
4. Demonstrated experience and knowledge of DSS, KLF, ACRP, and CHIPS database systems.
5. Knowledge of EDRP guidelines and other performance standards as they relate to PVAMC.
6. Ability to effectively communicate orally and in writing with a wide range of administrative and clinical staff.

### CONDITIONS OF EMPLOYMENT:

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Applicants without prior federal service will be appointed at step one of the grade

Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.

Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).
