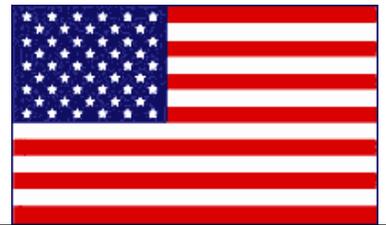

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.

MAJOR DUTIES:

The incumbent examines vouchers, invoices, claims, and other requests or payment for goods and services provided to or by the Government or for reimbursement of expenditures for travel and transportation, for accuracy, adequacy of documentation or citations, compliance with regulations, and justification. Examines a full range of vouchers having a wide variety of complicating conditions. Carefully analyzes each voucher or invoice to determine propriety of payment to include required certifications by authorized officials, compliance with contract provisions, price agreements, and/or other directive material. Determines the proper appropriation to be charged and that expenditures made are incurred only as specifically authorized. Coordinates and resolves discrepancies and/or problems.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: U.S. Office of Personnel Management Qualification Standards Handbook for GS-540 series apply and may be reviewed in the Human Resources Management Service office. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.

Specialized Experience: One (1) year of specialized experience that has equipped the applicant with the particular knowledge, skills, and abilities (KSA's) to perform successfully the duties of the position, and is typically in or related to the position to be filled. To be creditable, specialized experience must have been equivalent to at least the next lower grade level in Federal Service (GS-5).

BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to rating factors will result in applicant not being referred for the position:

1. Knowledge of complex procedures and rules concerning payment of government claims, and comprehensive financial and accounting processes and procedures.
2. Ability to interpret and apply complex regulations and procedures related to voucher examining.
3. Knowledge of a variety of computerized financial systems (IFCAP, CAPPS, and FMS for example) used to enter, modify and retrieve information in an automated general ledger system.
4. Ability to gather, analyze, and present facts.
5. Ability to communicate orally and in writing.

CONDITIONS OF EMPLOYMENT:

- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
- Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.
- Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).

APPLICANT'S PLEASE NOTE:
