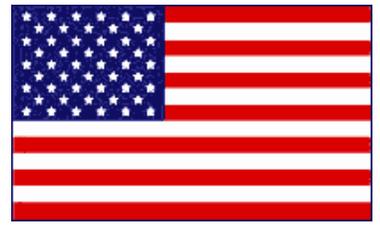

### WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees and permanent Title 38 Hybrid employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Career or career conditional employees and permanent Title 38 employees of other VA facilities.
- Applicants with competitive status outside the VA i.e., those with transfer or reinstatement eligibility.
- VEOA (Veterans Employment Opportunities Act) Veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after 3 or more years of continuous active service.
- **Noncompetitive Appointment of Certain Military Spouses**
  - Spouses of armed forces members who are involved in a Permanent Change of Station (PCS): You must include a copy of the service member's PCS Orders authorizing the spouse to accompany the service member and proof of marriage to the service member.
  - Spouses of armed forces members who retired or were released from active duty with a 100% disability: You must include proof that service member was released or discharged from active duty due to a service-connected disability, documentation of 100% disability, and proof of marriage to the service member.
  - Un-remarried widows or widowers of armed forces members killed while on active duty: You must include proof of service member's death while on active duty and proof of marriage to the service member.
- Employees covered under the provision of the inter-agency Career Transition Plan (ICTAP) and Career Transition Assistance Plan (CTAP) (displaced VA Employees) eligibles will be given priority consideration for vacancies within the **local commuting area** for which they are well qualified. Applicants requesting this consideration must attach appropriate proof of the ICTAP eligibility with their application. Well qualified is defined as an applicant, without any further training, can perform the major duties of the position which include audits all receivables to ensure correct rates are being used and supporting documentation is complete prior to being mailed to debtor. Receives and responds to a wide variety of correspondence generated by third party health plan carriers, vendors, other federal agencies and other sources concerning debts resulting from patient care.

### MAJOR DUTIES:

Provides general clerical or assistant support to the agency accounts receivable or debt collection function. Audits all receivables to ensure correct rates are being used and supporting documentation is complete prior to being mailed to debtor. Receives and responds to a wide variety of correspondence generated by third party health plan carriers, vendors, other federal agencies and other sources concerning debts resulting from patient care. Maintains suspense records on all correspondence and documents. Reviews payments for proper posting and adjusts accounts as needed. Prepares refund vouchers for debts that have been overpaid. Performs other related duties as assigned. Knowledge of the structure and content of fiscal related documents and government accounting practices in order to investigate and resolve routine or recurring discrepancies, check documents for adequacy, determine permissibility of transactions and respond to recurring questions from agency personnel. The work involves performing various support duties related to fiscal operations. The Fiscal Accounts Clerk examines information relative to accounts, which are due the Medical Center and where payees have questioned payments amounts. Examines all available information relative to accounts and determines the appropriate action to be taken which may involve auditing accounts, computing payments, analyzing computer data or printed material, replying to inquiries or referral of the debt.

## **QUALIFICATION REQUIREMENTS:**

**Eligibility:** U.S. Office of Personnel Management Qualification Standards Handbook for GS-0503, Financial clerical and assistance series apply and may be reviewed in the Human Resources Management Service office. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.

**Specialized Experience:** Experience that equipped the applicant with the particular knowledge, skills, and abilities (KSA's) to perform successfully the duties of the position, and that is typically in or related to the position to be filled. To be creditable, specialized experience must have been equivalent to at least the next lower grade level. Specialized experience includes, but is not limited to Payroll technician, Accounting technician/assistant and/or Administrative/clerical assistance in the area of accounting working with accounts receivables and/or debt collections.

**Substitution of Education for Experience:** Successful completion of four (4) years above high school. This education must have been obtained in an accredited business, secretarial or technical school, junior college, college or university. One year of full-time academic study is defined as 30 semester hours, 45 quarter hours, or the equivalent in a college or university, or at least 20 hours of classroom instruction per week for approximately 36 weeks in a business, secretarial, or technical school. If using education as a substitute for experience, please submit a copy of your college transcripts with application packet.

## **BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))**

*On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to the rating factors may result in your application receiving a less than desirable rating.*

1. Ability to review payments for proper posting and adjustments to patient accounts.
2. Ability to perform detailed accounting procedures.
3. Knowledge of the structure and content of fiscal related documents.
4. Ability to prioritize daily work assignments and meet stated goals.

## **CONDITIONS OF EMPLOYMENT:**

- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Applicants without prior federal service will be appointed at step one of the grade
- Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
- Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.
- If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.
- A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.
- Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.

**APPLICANT'S PLEASE NOTE:**
