

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to rating factors will result in applicant not being referred for the position:

1. Knowledge of specific sterilization equipment used within the Portland VA Medical Center including: **Steris** - warming cabinets, tunnel washer, washer/pasteurizer, sterilizers. **Getinge** – sterilizers, ultrasonic cleaners, cart washer, warming cabinets, glassware washer. **Custom Ultrasonic's** - scope washer. **Schlyer** - cage washer. The candidate must be able to provide technical support, maintenance and repair on all types of sterilization equipment. (screen out element)
2. Abilities to communicate effectively with the professional staff verbally and in writing so that proposals and consultations can be done without depending on assistance from the Electrical Foreman or Chief of Maintenance and Repair.
3. Ability to educate fellow employees on start-ups, in-service training for users and troubleshooting techniques and proper safety procedures for the end user.
4. Ability to use and maintain tools and equipment to safely set up for maintenance and repair work in and around bio-medical equipment both for your protection and other users.
5. Describe your knowledge of biomedical engineering technology, including electronics, pneumatics, mechanical disassembly/reassemble, sensors and transducers.

CONDITIONS OF EMPLOYMENT:

- Applicants without prior federal service will be appointed at step one of the grade
- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
- Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.
- If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.
- A security clearance and a favorable suitability determination are required.
