WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees and permanent Title 38 Hybrid employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.

THOSE WHO PREVIOUSLY APPLIED UNDER ANNOUNCEMENT MP-10-0087-TC NEED NOT REAPPLY, ALL APPLICATIONS UNDER PREVIOUS ANNOUNCEMENT WILL BE REFERRED UNDER THIS VACANCY.

- Career or career conditional employees and permanent Title 38 employees of other VA facilities.
- Applicants with competitive status outside the VA i.e., those with transfer or reinstatement eligibility.
- VEOA (Veterans Employment Opportunities Act) Veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after 3 or more years of continuous active service.
- Schedule A special hiring authority covers applicants with mental and physical disabilities. In order to be considered under this special hiring authority applicants need to provide proof of disability and job readiness certification. The proof of disability and job readiness certification can be provided by the following: 1) a statement or letter on a physician's/medical professional's letterhead; 2) statement, record or letter from a Federal Government agency that issues or provides disability benefits; 3) statement, record or letter from a State Vocational Rehabilitation Agency counselor; or 4) certification from a private Vocational Rehabilitation or other Counselor that issues or provides disability benefits. - **Noncompetitive Appointment of Certain Military Spouses**
 - Spouses of armed forces members who are involved in a Permanent Change of Station (PCS): You must include a copy of the service member's PCS Orders authorizing the spouse to accompany the service member and proof of marriage to the service member.
 - Spouses of armed forces members who retired or were released from active duty with a 100% disability: You must include proof that service member was released or discharged from active duty due to a service-connected disability, documentation of 100% disability, and proof of marriage to the service member.
 - Un-remarried widows or widowers of armed forces members killed while on active duty: You must include proof of service member's death while on active duty and proof of marriage to the service member.
- Employees covered under the provision of the inter-agency Career Transition Plan (ICTAP) and Career Transition Assistance Plan (CTAP) (displaced VA Employees) eligibles will be given priority consideration for vacancies within the **local commuting area** for which they are well qualified. Applicants requesting this consideration must attach appropriate proof of the ICTAP eligibility with their application. Well qualified is defined as an applicant, without any further training, can perform the major duties of the position which include verification of veterans' insurance coverage for inpatient and outpatient services, entering updated information, and maintaining the database.

MAJOR DUTIES:

The incumbent is responsible for the verification of veterans' insurance coverage for inpatient and outpatient services, entering updated information, and maintaining the database. Insurance coverage information is obtained through automated databases, direct patient contact, and contact with insurance companies. Incumbent verifies benefits, policy number, pre-certification requirements, insurance company contact information, and effective dates of coverage.

Documents pre-admission requirements and identifies patients requiring second opinions. Responsible for all reimbursable billing activities including consideration of professional services and facility services, sharing agreements, Tricare, Champ VA, Medicare, and pharmacy billing. Validates claims for billing purposes ensuring eligibility and referring questionable coding for review; monitors reports to assure all possible billable cases are processed; and ensures proper sequencing; of diagnostic and procedural codes and assigns modifiers as needed. Incumbent is responsible for third party collection from insurance companies and for accounts receivable including humanitarian, DoD, Tricare tort feaser, workman's compensation, fugitive felon, ineligible, CHAMP VA, and no-fault auto accidents. Researches and resolves problems and posts payments, adjustments, denial codes, and non-payment collections. Follows-up on accounts receivable; determines the accuracy of reimbursement received; responds to correspondence and inquiries; expedites and maximizes collections; maintains records; and makes debt adjustments and assigns funds received to the correct account. Verifies the accuracy of payments, resolves problems and discrepancies, and closes out accounts. Incumbent responds to questions and inquiries from veterans and insurance companies. Audits accounts, insuring payments recovered by insurance carrier are posted in a timely manner to the veterans Category C bills. Performs other related duties as assigned.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: U.S. Office of Personnel Management Qualification Standards Handbook for GS-503, Financial Clerical and Assistance series apply and may be reviewed in the Human Resources Management Service office. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.

Specialized Experience: One (1) year of specialized experience equivalent to the next lower grade. Experience must have equipped the applicant with the particular knowledge, skills, and abilities to perform successfully the duties of the position and that are typically in or related to the work of the position. To be creditable, specialized experience must have been equivalent to at least the next lower grade level. Specialized experience includes, but is not limited to insurance verification and claims, collections, billing, and maintaining patient accounts.

Substitution of Education for Experience: **GS-5:** 4 years of successfully completed education above the high school in any field for which high school level in any field for which high school graduation or the equivalent is the normal prerequisite is creditable. This must have been obtained in an accredited business, secretarial, or technical school, junior college, or university. **GS-6:** As a general rule, education is not creditable above GS-5 for most positions covered by this standard; however, graduate education may be credited in those few instances where the graduate education is directly related to the work of the position.

BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to the rating factors may result in your application receiving a less than desirable rating.

1. Knowledge of medical insurance terms, abbreviations, and benefits.
2. Experience in interviewing in order to extract complete and accurate information from insurance company representatives.
3. Ability to access various websites to determine eligibility and verify insurance coverage.
4. Knowledge of veteran's eligibility and third party payer regulations as they relate to insurance verification.
5. Knowledge of insurance authorization and pre-admission requirements.

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Applicants without prior federal service will be appointed at step one of the grade

Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.

This is a developmental position. If selected below the target level, employee may be promoted without further competition upon satisfactory completion of qualification and eligibility requirements.
