WHO MAY APPLY:

- Portland VA Medical Center career or career conditional employees and permanent Title 38 and Title 38 Hybrid employees eligible under the interchange agreement. (See conditions of employment).

BARGAINING UNIT POSITION: No

MAJOR DUTIES: The incumbent serves as the Assistant Chief SPD under the direction of the Chief, SPD, and is responsible for the overall management of SPD day to day operation, including instrument reprocessing and RME reprocessing for all clinical services supported by Portland VA Medical Center, including additional campus in Vancouver and 6 CBOC's. SPD is the central point from which patient care, medical and surgical instruments and equipment are received, processed, packaged, and distributed throughout the medical center. Portland VA Medical Center is a tertiary medical center with 14 total OR suites, including liver and kidney transplants, open heart and complex orthopedic cases, averaging over 7500 surgical cases per year. SPD must provide 24 hour coverage to sustain the needs of the medical center. SPD provides support to the GI Endoscopy Suite and must ensure the rapid turnaround of various types of endoscopes, all with unique manufacturer requirements for reprocessing. SPD must ensure all RME used throughout the medical center is reprocessing according to manufacturers recommendation and available for use on all patient care units and clinics, including two fully functioning dental clinics.

Incumbent will oversee the lead technicians, technicians, volunteers, and interns/students whose duties are to receive, process, package and distribute all OR instrumentation, critical and noncritical RME, throughout PVAMC. Incumbent is required to be Level II Certified and understand sterilization parameters, biological monitoring, preparation and packaging, supply handling and storage, and strict compliance of the VA Handbook/Directive 7176 Directives - Supply, Processing, and Distribution Operational Requirements, the Joint Commission Regulations, as well as all local policies and procedures, and other SPD related regulatory standards and guidelines.

QUALIFICATIONS:

- **Eligibility:** U.S. Office of Personnel Management <u>Qualification Standards</u> Handbook for GS-0622. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.
- Basic Requirements: Must be a U.S. citizen.
- Specialized Experience: GS-10: One year of specialized work experience at the next lower grade level (GS-9). Specialized experience includes processing, assembling, trouble-shooting, preparing, sterilizing, storing, and issuing sterile and unsterile medical supplies and equipment. sterilization, and storage procedures; aseptic techniques; and skill in operating a washer-sterilizer, ultrasonic instrument cleaners, and gas and steam sterilizers. Examples of qualifying specialized experience include work as an operating room technician, medical instrument technician, or medical supply technician. One full year is defined as 12 months of full-time employment, part-time employment is pro-rated based on a full-time schedule (i.e., 20 hours per week is 50 percent of full-time, therefore 12 months at 20 hours per week would count as six months of experience).
