MAJOR DUTIES: This position is located at the Hillsboro Community Based Outpatient Clinic (CBOC), Veteran & Staff Services, Compensation & Pension Unit. The Incumbent receives all requests (2507's) initiated from VBA (includes appeals board) or DOD for C & P examinations, prepares the request for initial review/orders by the clinician, schedules all appointments into the decentralized hospital computer program (DHCP) and notifies the veteran by mail and or telephone of the appointment(s). When scheduling the incumbent constantly checks clinic availability for all C&P providers to assure the earliest available appointment is scheduled and assures the veteran/service member is given appropriate instruction for reaching the exam site and for completing any testing that may be required. He/she advises the Lead of any scheduling problems. The incumbent prepares paperwork for each clinic, and assures that the medical record and claims files are included, and assures delivery prior to and pick-up after the clinic is completed. The incumbent keeps track of all C-File and assures that all are accounted for at all times. The incumbent assures that all C-Files are returned to the RO in a timely manner. Manages patient data; schedules appointments and generates correspondence relating to appointment activity; manages workload through the use of add/edit clinic stops following outpatient visits and performs and other VISTA/AMIE related tasks that are appropriate in the range of special examinations. He/she also advises clients on special programs, e.g., Agent Orange, Persian Gulf, Ionizing, Radiation, Women's Health, etc., and coordinates referrals in a manner that avoids unnecessary referrals to other administrative program managers. The incumbent is responsible for triaging all 2507's received from Regional Office (RO) by determining exam types, contacting the RO for clarification of exam types and assessing requests for "expedite" requirements, length of appointment and entering information into Compensation and Pension System (CAPS).

QUALIFICATIONS:

- **Eligibility:** U.S. Office of Personnel Management [Qualification Standards](#) Handbook for GS-0679. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.
- **Basic Requirements:** Must be a U.S. citizen.

- **Specialized Experience:** At least one year of experience that equipped the applicant with the particular knowledge, skills, and abilities (KSA's) to perform successfully the duties of the position, and that is typically in or related to the position to be filled. To be creditable, specialized experience must have been equivalent to at least the next lower grade level. Specialized experience includes, but is not limited to; Manages patient data; schedules appointments and generates correspondence relating to appointment activity; manages workload through the use of add/edit clinic stops following outpatient visits and performs and other VISTA/AMIE related tasks that are appropriate in the range of special examinations.

- **Basis for Rating: Knowledge, Skills and Abilities**

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to the rating factors may result in your application receiving a less than desirable rating.

1. Knowledge of medical terminology and understanding of various types of examinations in order to correctly schedule Veterans for examinations and procedures.
2. Knowledge of examination elements required to be able to set up specialty exams with appropriate specialty.
3. Ability to utilize Microsoft Office, to include Word, Excel, Outlook and other software applications, such as VISTA and CPRS.
4. Knowledge and skill in scheduling appointments; ensuring all items required for examinations are provided to be examiners.

CONDITIONS OF EMPLOYMENT:

- **Priority Consideration:** Individuals who have special priority selection rights under the Agency Career Transition Assistance Program (CTAP) or the Interagency Career Transition Assistance Program (ICTAP) must be well qualified for the position to receive consideration for special priority selection. CTAP and ICTAP eligibles will be considered well qualified if they can perform the duties of the position at the full performance level and the full range. The incumbent prepares paperwork for each clinic, and assures that the medical record and claims files are included, and assures delivery prior to and pick-up after the clinic is completed. The incumbent keeps track of all C-File and assures that all are accounted for at all times. The incumbent assures that all C-Files are returned to the RO in a timely manner. Manages patient data; schedules appointments and generates correspondence relating to appointment activity; manages workload through the use of add/edit clinic stops following outpatient visits and performs and other VISTA/AMIE related tasks that are appropriate in the range of special examinations.

- **Noncompetitive Appointment of Certain Military Spouses**

- Spouses of armed forces members who are involved in a Permanent Change of Station (PCS): You must include a copy of the service member's PCS Orders authorizing the spouse to accompany the service member and proof of marriage to the service member.
- Spouses of armed forces members who retired or were released from active duty with a 100% disability: You must include proof that service member was released or discharged from active duty due to a service-connected disability, documentation of 100% disability, and proof of marriage to the service member.
- Un-remarried widows or widowers of armed forces members killed while on active duty: You must include proof of service member's death while on active duty and proof of marriage to the service member.

- **VEOA (Veterans Employment Opportunities Act)** Veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after 3 or more years of continuous active service.

- **Schedule A** special hiring authority covers applicants with mental and physical disabilities. In order to be considered under this special hiring authority applicants need to provide proof of disability and job readiness certification. The proof of disability and job readiness certification can be provided by the following: 1) a statement or letter on a physician's/medical professional's letterhead; 2) statement, record or letter from a Federal Government agency that issues or provides disability benefits; 3) statement, record or letter from a State Vocational Rehabilitation Agency counselor; or 4) certification from a private Vocational Rehabilitation or other Counselor that issues or provides disability benefits. - Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Applicants without prior federal service will be appointed at step one of the grade
- Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
- Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.
- If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the [Selective Service](#) System, unless you meet certain exemptions.
