BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to rating factors will result in applicant not being referred for the position:

1. Ability to work well with all levels of staff within a medical center environment as well as a wide variety of outside contacts as the representative/liason for the Chief of the Service in order to schedule meetings, conference calls, etc.
2. Knowledge of various office computer and software programs, i.e., Outlook, Word, Vista and Excel, Access, CPRS.
3. Knowledge of timekeeping duties for varied and highly complex staff
4. Knowledge of office policies and procedures, grammar, punctuation, spelling, etc. in order to prepare outgoing correspondence, meeting minutes, reports, memorandums and other forms of written communications.

CONDITIONS OF EMPLOYMENT:

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Applicants without prior federal service will be appointed at step one of the grade

Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.
