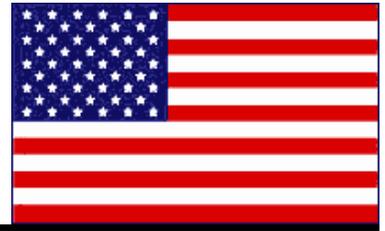

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Any US Citizen

MAJOR DUTIES:

Incumbent performs a variety of duties pertaining to the examination and certification of vouchers for payment and collection involving various appropriations and determines that the expenditure or collection is authorized by law and the authority and/or method is cited on the voucher or related support documents. Determines that the authorization on procurement order indicates its issuances as a prior authority for the delivery of articles or the furnishing of services. Determines that the transaction complies fully with the laws or regulations. Enters all invoices into tracking system to auditing or invoices and matching receiving reports for all subsistence purchase orders. Prepares suspension letters to vendors with suspendable items such as overages, discrepancies with purchase orders in regards to items not ordered. Prepares Bills of Collection for overpayments and/ or payments made in error or requests initiating service to comply. Answers and/ or initiate vendor inquiries when necessary in the daily course of business wither by telephone or correspondence. Receipts for a variety of collections and must be able to identify proper appropriation or account to be credited. Prepares a variety of documents and maintain all accountable forms used in performance of duties. Performs other duties as assigned.

QUALIFICATION REQUIREMENTS:

Eligibility: U.S. Office of Personnel Management Qualification Standards Handbook for GS-540 series applies and may be reviewed in the Human Resources Management Service office.

Specialized Experience: One (1) year experience that equipped the applicant with the particular knowledge, skills, and abilities (KSA's) to perform successfully the duties of the position, and that is typically in or related to the work of the position to be filled. To be creditable, specialized experience must have been equivalent to at least one year at the GS-4 level.

Substitution of Education for Experience: Successful completion of four (4) years of post high school education. Post high school education must have been obtained in an accredited business, secretarial, or technical school, junior college, or university. **If using education as a substitute for experience, please submit a copy of your college transcripts with application packet.**

BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to rating factors will result in applicant not being referred for the position:

1. Ability to process payments in accordance with contract and applicable regulations, laws and policies
2. Knowledge of the Integrated Funds Distribution, Control Point Activity, Accounting and Procurement (IFCAP) and Financial Management System (FMS); or manual or automated accounting systems.
3. Knowledge of the various VA or Federal appropriations and funds.
4. Ability to calculate discounted rates.

CONDITIONS OF EMPLOYMENT:

Applicants without prior federal service will be appointed at step one of the grade
 Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
 Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.

 - c. VA letter of service-connected disability rating dated 1991 or later.
4. SF-50, Notification of Personnel Action (if applying as a current or former federal employee).
5. Narrative statement relating to all of the KSAs. Candidates **must** submit a narrative statement on a separate page(s) with specific responses to all of the knowledge, skills, and abilities (KSAs) in this announcement. Failure to submit your narrative response to all of the KSAs will result in the applicant not being referred for the position.
6. A copy of your college transcripts (Optional unless education is required).
