

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees and permanent Title 38 Hybrid employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Career or career conditional employees and permanent Title 38 employees of other VA facilities.
- Applicants with competitive status outside the VA i.e., those with transfer or reinstatement eligibility.
- Veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after 3 or more years of continuous active service.
- Employees covered under the provision of the inter-agency Career Transition Plan (ICTAP) and Career Transition Assistance Plan (CTAP) (displaced VA Employees) eligibles will be given priority consideration for vacancies within the **local commuting area** for which they are well qualified. Applicants requesting this consideration must attach appropriate proof of the ICTAP eligibility with their application.

MAJOR DUTIES:

The Lead Supply Technician position is located in Supply, Processing & Distribution (SPD), an organizational element of Acquisition and Materiel Management Service (A&MM). Employee is responsible for ensuring the work assignments of SPD technicians are carried out effectively and efficiently, providing the training and guidance necessary to perform their duties in accordance with the program elements of the Generic Inventory Package (GIP) and OmniCell. Employee is responsible for distributing and balancing the workload among employees to ensure the timely accomplishment of the workload. This includes making sure employees have enough work to keep busy and are performing their duties in a manner that reflects the best interests of the Medical Center. Incumbent must make day-to-day adjustments in duty assignments in accordance with established priorities, and resolve simple, informal complaints, obtaining assistance, as necessary, from the supervisor. Employee, using task/person association techniques, instructs employees in specific tasks and job techniques and provides written instructions, reference materials and supplies to facilitate job completion.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: U.S. Office of Personnel Management Qualification Standards Handbook for GS-2005 series applies and may be reviewed in the Human Resources Management Service office.

Specialized Experience: One (1) year that equipped the applicant with the particular knowledge, skills, and abilities (KSA'S) to perform successfully the duties of the position to be filled. To be creditable, specialized experience must have been equivalent to at least the next lower grade level.

BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to rating factors will result in applicant not being referred for the position:

1. Knowledge of inventory and replenishment practices including, but not limited to, the establishments of economic levels, turn-over rates, low/no use requirements, expiration dates and package integrity.
2. Knowledge of the Generic Inventory Package (GIOP) and OmniCell which enables the incumbent to suggest level changes, establish re-order points, generate UPC labels, and solve problems with picking tickets and stock on hand.
3. Knowledge of aseptic techniques, supplies, and equipment, and the advantages of the various types of cleaning agents, detergents, disinfectants, cleaning techniques, and sterilizing mediums, sufficient to ensure proper

packaging, storage, and shelf-life practices are observed.

4. Knowledge of how to protect printed and electronic files containing information contained on the Medical Center's ADP system from unauthorized release, loss, alteration, or deletion and apply applicable regulations and instructions regarding access to computerized files.

CONDITIONS OF EMPLOYMENT:

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Applicants without prior federal service will be appointed at step one of the grade

Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

7. ITCAP Applicants: Submit proof by including a copy of the agency notice, most recent Performance Rating and most recent SF-50 indicating current position, grade, level, and duty station.
