



## **BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))**

***On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to rating factors will result in applicant not being referred for the position:***

1. Ability to perform procedures commonly performed by NA's such as catheterizing, irrigating, and suctioning patients; and other supporting procedures such as patient charting and patient/family teaching.
2. Knowledge of equipment, drug and medical terminology.
3. Skill to provide and gather information inpatient care/family conferences with nurses, doctors, patients and family members.
4. Knowledge of medical disease process, cardiac rhythms and telemetry monitoring equipment.
5. Ability to utilize CPRS, basic computer software, mouse and keyboards, complex monitoring equipment, multi-line phone equipment and pagers.
6. Ability to prioritize and complete multiple tasks.
7. Knowledge of documentation requirements which include logs, rhythm strips and arrhythmia reviews, patient charting and patient/family teaching.

## **CONDITIONS OF EMPLOYMENT:**

Applicants without prior federal service will be appointed at step one of the grade

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.

A drug test may be required for an applicant who is tentatively selected.

A pre-employment physical examination will be required for an applicant who is tentatively selected.
