

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees and permanent Title 38 Hybrid employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Career or career conditional employees and permanent Title 38 employees of other VA facilities.
- Applicants with competitive status outside the VA i.e., those with transfer or reinstatement eligibility.
- Veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after 3 or more years of continuous active service.
- Employees covered under the provision of the inter-agency Career Transition Plan (ICTAP) and Career Transition Assistance Plan (CTAP) (displaced VA Employees) eligibles will be given priority consideration for vacancies within the **local commuting area** for which they are well qualified. Applicants requesting this consideration must attach appropriate proof of the ITCAP eligibility with their application.

MAJOR DUTIES:

The incumbent is responsible for dealing with routine and problem issues in the following ER/LR areas of responsibility to ensure compliance with Title 5, Title 38 and Joint Commission on Accreditation of Healthcare Organizations (JACHO) requirements. Assists E/R specialists in development and maintenance of PVAMC Title 5 ECF, 5-Tier and Pass-Fail performance appraisal control system and database. Assists E/R specialists in development and maintenance of Title 38 proficiency reports and competencies in order to ensure that PVAMC meets Title 38 and JACHO requirements. Assists E/R specialists by developing case files, drafts, complete evidence packages and suspenses to ensure compliance with Title 5, Title 38 and Master Labor Agreement requirements. Processes requests for establishment of or changes to tours of duty throughout the medical center. This includes request for compressed tours and Flexitours, requests for leave under Family Medical Leave Act, requests for extended LWOP, Advanced Sick leave/Annual leave, Military leave and LWOP during active duty deployments. Processes and maintains PVAMC Employee Awards Program records, databases and actions for Title 5 and Title 38 employees. Advises employees, managers and supervisors on complex aspects of retirement, TSP, health and life insurance. Processes applications and requests for complex changes for various benefits programs. This includes maintaining databases and preparing reports. Prepares complete application package for retirement including estimates of annuity, forms and supporting documentation. Performs other related duties as assigned.

QUALIFICATION REQUIREMENTS:

Eligibility: U.S. Office of Personnel Management Qualification Standards Handbook for GS-203 series apply and may be reviewed in the Human Resources Management Service office. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.

Specialized Experience: One (1) year of specialized experience equivalent to the next lower grade. Experience must have equipped the applicant with the particular knowledge, skills, and abilities to perform successfully the duties of the position and that are typically in or related to the work of the position. To be creditable, specialized experience must have been equivalent to at least the next lower grade level.

Substitution of Education for Experience: **GS-5:** Successful completion of four years of education above the high school level in any field for which high school graduation or the equivalent is a prerequisite may be substituted in full for the specialized experience requirement ; **GS-6 & 7:** Not applicable. If using education as a substitute for experience, please submit a copy of your college transcripts with application packet.

CONDITIONS OF EMPLOYMENT:

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Applicants without prior federal service will be appointed at step one of the grade

Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

This is a developmental position. If selected below the target level, employee may be promoted without further competition upon satisfactory completion of qualification and eligibility requirements.
