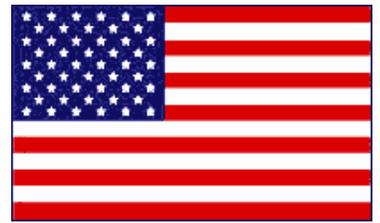

WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees and permanent Title 38 Hybrid employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Career or career conditional employees and permanent Title 38 employees of other VA facilities.
- Applicants with competitive status outside the VA i.e., those with transfer or reinstatement eligibility.
- Veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after 3 or more years of continuous active service.
- Employees covered under the provision of the inter-agency Career Transition Plan (ICTAP) and Career Transition Assistance Plan (CTAP) (displaced VA Employees) eligibles will be given priority consideration for vacancies within the **local commuting area** for which they are well qualified. Applicants requesting this consideration must attach appropriate proof of the ICTAP eligibility with their application.
- **Position may be filled as a Readjustment Counseling Therapist, Clinical Psychologist, or Social Worker.**

MAJOR DUTIES:

The incumbent provides services to sexually traumatized veterans of all eras who present a wide range of psychosocial problems that resulted from a physical assault or battery, or sexual harassment which occurred on active military duty. Plans and conducts comprehensive readjustment counseling, outreach, and follow-up programs for this special population. The major emphasis is placed on the social, emotional and psychological needs of sexually traumatized veterans and their significant others, which may include psycho-education, medical treatment, vocational rehabilitation and referrals. Assists the veterans in these matters by working in concert with other members of the Vet Center staff as well as professionals at the VA Outpatient Clinic, VA medical Center, outreach team, and community organizations. Conducts outreach activities in coordination with the Vet Center Team Leader and staff, and any applicable VAMC/OPC staff such as women veterans coordinators, to apprise sexually traumatized veterans of the availability of counseling for sexual trauma sustained while on military duty. Outreach activities are focused on bringing these sexually traumatized veterans in need of readjustment counseling into treatment. Presents information and discusses the clinical activities and philosophy of this program with other professionals and with members of community, state and federal agencies who come in contact with sexually traumatized veterans. Presents insightful and in-depth explanations of the therapeutic modalities required in counseling veterans who have encountered sexual trauma or sexual harassment. Establishes reciprocal referral practices with VA and community agencies and makes regular referrals when appropriate. Provides opportunity for medical screening. Maintains a list of agencies and organizations outside VA which provide such rehabilitative services. Works closely with the Team Leader in developing, implementing, and maintaining a systematic follow-up program for continuous objective assessment of treatment effectiveness in persons who are no longer in treatment. Encourages veterans who have left treatment to re-enter if necessary. Engages in therapeutic relationships with sexually traumatized veteran clients and takes an active role in evaluation and decision making conferences related to client treatment plans and progress. Conducts psychosocial assessments of clients that include personal, family, and social background histories, as well as peer relations and other interpersonal interaction information. Participates in and assists the Team Leader in doing research. Participates in staff development and diagnostic assessment and therapeutic conferences. Participates in supervision and teaching of social work field placements. Participates in the preparation of statistics and reports and

participates in VA-sponsored research activities. May also report on the effectiveness of various treatment interventions. Assists the Team Leader in other general duties, as appropriate. Attends appropriate educational programs, seminars, etc., for the purpose of improving services of the sexual trauma counseling program.

THIS POSITION IS EXCLUDED FROM THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Eligibility: U.S. Office of Personnel Management Qualification Standards Handbook for GS-101 series applies and may be reviewed in the Human Resources Management Service office. Regulatory requirements such as "time-in-grade" and "time after competitive appointment" are applicable.

Basic Requirements: Degree: behavioral or social science; or related disciplines appropriate to the position. **–OR–** Combination of education and experience--that provided the applicant with knowledge of one or more of the behavioral or social sciences equivalent to a major in the field. **–OR–** Four years of appropriate experience that demonstrated that the applicant has acquired knowledge of one or more of the behavioral or social sciences equivalent to a major in the field.

Specialized Experience: One (1) year that equipped the applicant with the particular knowledge, skills, and abilities (KSA's) to perform successfully the duties of the position to be filled. To be creditable, specialized experience must have been equivalent to at least the GS-9 level.

Substitution of Education for Experience: 3 years of progressively higher level graduate education leading to a PH.D. degree or PH.D. or equivalent doctoral degree. If using education as a substitute for experience, please submit a copy of your college transcripts with application packet.

BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to rating factors will result in applicant not being referred for the position:

1. Skill in developing and using community resources. Describe your achievements in which you designed and implemented new and innovative programs or were involved in the utilization of existing community programs. Describe your accomplishment(s) which demonstrate skill in developing and using community resources.
2. Ability to set goals and adjust to changing demands. Describe achievements which demonstrate your ability to establish priorities, goals and objectives for yourself and others, to adjust to new and changing demands, to synthesize information quickly and take appropriate action in dealing with acute patients.
3. Ability to assess patient needs and formulate a treatment plan. Describe achievements which highlight your use of a variety of assessment techniques and treatment approaches including patient needs assessment and treatment planning.
4. Ability to provide psychosocial treatment in various treatment modalities. Describe achievements which demonstrate how you have established therapeutic relationships with a variety of patients and carried out a psychosocial treatment plan.
5. Ability to communicate orally and in writing with a wide variety of individuals. This typically includes professionals in other health care disciplines and health/benefits groups in the community.
6. Skill in interacting with a diverse population of individuals who have experienced sexual trauma. Describe achievements working with specialized populations.

CONDITIONS OF EMPLOYMENT:

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Applicants without prior federal service will be appointed at step one of the grade

Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.
