WHO MAY APPLY TO THIS ANNOUNCEMENT:

Any US Citizen.

MAJOR DUTIES:

HUD-VASH is an intensive case management program for chronically homeless Veterans aimed at providing psychosocial services to Veterans while residing in stable housing through HUD's Section 8 voucher system. The social worker in this position functions as the Case Manager for PVAMC's Housing and Urban Development / VA Supportive Housing (HUD-VASH). The social worker is responsible for coordination of case management services for Veterans receiving housing provided through HUD Section 8 housing vouchers. Housing Choice Voucher (HCV) program funding will provide rental assistance under a supportive housing program for homeless Veterans authorized by section 8(o)(19) of the United States Housing Act of 1937, 42 U.S.C. 1437f(o)(19). The initiative is known as the HUD-VASH program and was authorized pursuant to Division K, Title II, of The Consolidated Appropriations Act, 2008 (Pub. Law 110-161) ("2008 Appropriation Act") enacted on December 26, 2007 (see proviso (7) under the heading "Tenant-Based Rental Assistance"). The HUD-VASH program combines HUD HCV rental assistance for homeless Veterans with case management and clinical services provided by the Department of Veterans Affairs (VA) at its medical centers and in the community. Ongoing VA case management, healthcare, and other supportive services will be made available to homeless Veterans at as many as 132 VA Medical Center (VAMC) supportive services sites across the nation.

QUALIFICATION REQUIREMENTS:

<u>Eligibility</u>: Department of Veterans Affairs Qualifications Standards (VA Handbook 5005, Part II, Appendix G39) for GS-185 series applies and may be reviewed in the Human Resources Management Service Office.

Basic Requirements:

- a. **Citizenship.** Be a citizen of the United States. (Non-citizens may be appointed when it is not possible to recruit qualified citizens in accordance with chapter 3, section A, paragraph 3g this part.)
- b. **Education.** Have a master's degree in social work [] from a school of social work fully accredited by the Council on Social Work Education (CSWE). Graduates of schools of social work that are in candidacy status do not meet this requirement until the school of social work is fully accredited. A doctoral degree in social work *may not* be substituted for the master's degree in social work. [Verification of the degree can be made by going to the CSWE website to verify if that social work degree meets the accreditation standards for a master of social work.]
- c. **Licensure.** Persons hired or reassigned to social worker positions in the GS-185 series in VHA must be licensed by a state to independently practice social work at the master's degree level. Current state requirements may be found on the OHRM website.

<u>Specialized Experience:</u> The GS-12 requires experience that demonstrates possession of advanced practice skill and judgment. The incumbent must be licensed or certified by a state at the advanced practice level which included an ASWB advanced generalist or clinical examination, unless they are grandfathered by the state in which they are licensed to practice at the advanced practice level (except for licenses issued in California, which administers its own clinical examination for advanced practice). Specialized experience includes, but is not limited to; case management, indentifying, assessing and determining patient needs and high risk patients, knowledge of mental health diagnosis and of treatment methodologies, knowledge of psychosocial assessments, interventions and measuring outcomes.

Substitution of education for experience: No substitution is generally accepted at the GS-0185-12 level.

BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to rating factors may result in your application receiving a less than desirable rating.

- 1. Skills and experience in interacting with multidisciplinary health care teams.
- 2. Ability to assess patient needs and formulate and implement a treatment plan.
- 3. Ability to provide psychosocial treatment to Mental Health patients.
- 4. Skills in developing and using community resources.

CONDITIONS OF EMPLOYMENT:

- This is an Excepted Appointment. Excepted service positions have been excepted from the requirements of the
 competitive service by law, Executive Order, or by OPM regulation (5 USC 2103 and 5 CFR part 213). Public
 law No. 108-170 converts this occupational series from the competitive civil service to the Hybrid Title 38
 employment system.
- Applicants without prior federal service will be appointed at step one of the grade
- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future.
- Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.
- All information submitted to this VA Medical Center is subject to verification by VetPro.
- If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law.
 - (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.
- A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.
- Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.
- Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
- Applicants selected for this position may be appointed to a temporary appointment, NTE 13 months, pending completion of boarding process.
- This is a developmental position. If selected below the target level, employee may be promoted without further competition upon satisfactory completion of qualification and eligibility requirements.
- A drug test may be required for an applicant who is tentatively selected.
- A pre-employment physical examination will be required for an applicant who is tentatively selected.
- Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).

APPLICANT'S PLEASE NOTE:
